An Act establishing a youth suicide prevention \* [demonstration] \* program and making an appropriation therefor.

#### STATEMENT

The incidence of adolescent suicide has grown alarmingly over the last 20 years, from a rate of 5.2 per 100,000 youths in 1960 to a rate of 12.5 per 100,000 in 1980. Suicide is now the second leading cause of death among adolescents aged 15 through 24. Professionals agree that no single theory can account for all suicides and no single measure can prevent them; however, the increase in suicides among adolescents is often attributed to the pressures that the changing values, lifestyles and family relationships in our society have placed on the adolescents. While suicides cannot be prevented in all cases, many experts agree that suicides among adolescents can be reduced through organized programs in the schools and in the community which teach adolescents, their parents and teachers about suicide and how suicide may be prevented.

In response to the need for organized programs dealing with adolescent suicide, this bill establishes a demonstration youth suicide prevention program in the Department of Education. The Commissioner of Education is directed to establish guidelines for prevention projects which will be administered by local boards of education in cooperation with community mental health services providers. The commissioner will solicit proposals for model projects from local boards of education and select and fund at least two projects for the demonstration program. The bill appropriates \$75,000.00 to carry out the program.

The demonstration program will operate for three years and at the end of the program the Commissioner of Education is required to report to the Legislature and Governor on the effects of the program and provide recommendations for establishing suicide prevention programs Statewide.

The mental health services providers shall submit suicide prevention project proposals to the commissioner who shall select and fund three proposals, one each from the northern, central and southern regions of the State. As part of their proposal, the providers are responsible for obtaining the cooperation of at least two local boards of education with which the prevention projects will be carried out. The providers will also provide information and training to other boards of education upon their request and within the limits of available funds. The participation in the program of local boards of education is voluntary.

The membership of the advisory council in the bill includes the Commissioners of Human Services and Education, the project directors of the three funded prevention projects and five public members, including two persons who are generally knowledgable about issues concerning suicide, a local school board member, a school administrator and a secondary classroom teacher.

The council is directed to compile information about suicide prevention programs in the State; disseminate this information to local boards of education, mental health providers and the public; assess the most

effective and efficient means for providing prevention services Statewide; and advise the commissioners on matters pertaining to youth suicide. The council shall report to the Legislature and Governor 18 months from the effective date of the bill.

This bill, which passed the Senate 35 to 0 on December 17, 1984, is identical to Assembly Bill No. 2286 Aca (Otlowski) which the committee reported at the same time. The committee reported this bill favorably without amendments.

#### Provisions:

Senate Bill No. 2005 (2nd OCR) establishes, in the Department of Human Services, a youth suicide prevention program and a ten member Youth Suicide Prevention Advisory Council. There is an appropriation of \$300,000.00.

#### BACKGROUND:

Three regional suicide prevention projects are to be established, each based on a proposal submitted by a community mental health services provider in cooperation with at least two interested school districts. The projects would provide for staff training, classroom instruction and materials, parent education, non-school crisis intervention programs and other school and community outreach services. The council is to report to the Governor and the Legislature, in 18 months, an assessment of the effects of the projects and the need and costs for a Statewide program.

#### FISCAL IMPACT:

There is a \$300,000.00 appropriation from the General Fund, of which at least \$255,000.00 must be used to fund the three projects selected by the Commissioner of Human Services.

#### OTHER LEGISLATION:

This bill is identical to Assembly Bill No. 2286 (OCR).

The committee favorably reports this bill.

The membership of the advisory council established in the bill includes the Commissioners of Human Services and Education, the project directors of the three funded prevention projects and five public members including two persons who are generally knowledgeable about issues concerning suicide, a local school board member, a school administrator and a secondary classroom teacher.

The council is directed to compile information about suicide prevention programs in the State; disseminate this information to local

boards of education, mental health providers and the public; access the most effective and efficient means for providing prevention services Statewide; and advise the commissioners on matters pertaining to youth suicide. The council shall report to the Legislature and Governor 18 months from the effective date of the act.

The committee adopted several substantive amendments to the bill in response to comments made by representatives of the education and mental health communities. The amendments: move responsibility for the program to the Department of Human Services and authorize community mental health services providers in consultation with local boards of education to administer the program; specify that three instead of two projects shall be funded; delete references to a demonstration program; establish a 10 member advisory council; and increase the appropriation to \$150,000.00.

# STATE OF NEW JERSEY

This bill establishes a youth suicide prevention program in the Department of Human Services and a 10-member Youth Suicide Prevention Advisory Council. As amended, an appropriation of \$300,000.00 is included to fund the program and council activities.

The bill requires the Commissioner of Human Services to establish and fund three regional youth suicide prevention projects, each based on a proposal submitted by a community mental health services provider in cooperation with at least two interested school districts. The projects would provide for staff training, classroom instruction and materials, parent education, non-school crisis intervention programs and other school and community outreach services.

The Youth Suicide Prevention Advisory Council would comprise the Commissioners of Human Services and Education, the three project directors, one school board member, one school administrator, one teacher and two additional public members. The council is to report to the Governor and Legislature in 18 months, including in its report an assessment of the effects of the three regional projects and an assessment of the needs and costs for a Statewide youth suicide prevention program.

#### FISCAL IMPACT

The bill appropriates \$300,000.00 from the General Fund, of which at least \$255,000.00 must be used to fund the three regional suicide prevention projects selected by the Commissioner of Human Services.

#### COMMITTEE AMENDMENTS

At the request of the sponsor, the committee increased the appropriation for the youth suicide prevention program from \$150,000.00 to \$300,000.00.

Legislation establishing three youth suicide prevention programs in New Jersey in a concerted effort to curb the rising incidence of youthful suicides was signed today by Governor Thomas H. Kean.

The Governor signed the legislation, which appropriates \$300,600 for the programs, at a public ceremony held at Rutherford High School.

The legislation,  $\underline{S-2005}$ , was sponsored in the Senate by Senator Richard Codey, D-Essex, and in the Assembly,  $\underline{A-2286}$ , by Assemblyman George Otlowski, D-Middlesex.

"This legislation is a response to what can only be seen as a cry for help --- a call to end the tragedy of self destructiveness by teenagers and young adults," Kean said. "The epidemic of teen suicides must be stemmed and prevented from recurring."

"It is difficult to understand and even more difficult to accept the death of a young person, particularly when the death is by his or her own hand," Kean said. "We must seek ways to recognize suicidal symptoms, to offer counseling and to ease the pressures placed on young people in today's society."

The Governor pointed out that suicide is now the second leading cause of death among the 15 to 24 year old age group.

"The data is both startling and frightening," he said. "The rate of adolescent suicide is now 12.5 per 100,000 persons, more than double the rate of 20 years ago."

"While suicides cannot be prevented in every case, their incidence can be reduced significantly through organized programs in schools and in the community generally," Kean said.

The legislation signed by Kean provides for a suicide prevention program in the northern, central and southern parts of the State. Each program would receive a \$100,000 appropriation from the Department of Human Services and would be carried out by local mental health service providers.

As a part of the proposal, the local providers would be required to obtain the cooperation of at least two local boards of education with which the prevention projects would be carried out.

The legislation also creates a 10-member Youth Suicide Prevention Advisory Council which will be responsible for compiling information concerning prevention programs and disseminating the data to local boards of education, mental health service providers and the public at large.

The Council is also directed to assess the most effective and efficient means of providing prevention services Statewide and to advise the Commissioners of Health and Education on matters involving youth suicide. The Council is directed to report to the Governor and the Legislature in 18 months on its findings.

The Council membership is to be comprised of the Commissioners of Human Services and Education, the project directors of the three programs to be funded by the State and five public members, including two persons knowledgeable in issues concerning suicide, a local school board member, a school administrator and a secondary school teacher.
