## INTRODUCED MAY 13, 1985

An Act concerning credit for military service for teaching staff members, supplementing chapter 28 of Title 18A of the New Jersey Statutes and amending N. J. S. 18A:28-12.

- 1 BE IT ENACTED by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. (New section) In computing length of service for seniority
- 2 purposes, every teaching staff member who, after July 1, 1940, has
- 3 served or hereafter shall serve, in the active military or naval
- 4 service of the United States or of this State, including active ser-
- 5 vice in the women's army corps, the women's reserve of the naval
- 6 reserve, or any similar organization authorized by the United States
- 7 to serve with the army or navy, in time of war or an emergency,
- 8 or for or during any period of training, or pursuant to or in con-
- 9 nection with the operation of any system of selective service, shall
- 10 be entitled to receive equivalent years of employment or seniority
- 11 credit for that service as if the member had been employed for the
- 12 same period of time in some publicly owned and operated college,
- 13 school or institution of learning in this or any other state or
- 14 territory of the United States, except that the period of that

- 2 18A:28-12. If any teaching staff member shall be dismissed as

- 1 3. This act shall take effect immediately.

#### STATEMENT

This bill would provide that in computing length of service for seniority purposes, teaching staff members are entitled to receive equivalent years of employment or seniority credit for military service except that the period of that service shall not be credited toward more than four years of employment or seniority credit.

Additionally, this bill would establish a four year maximum on the amount of military service time that is applied toward the seniority for teaching staff members under the current military service credit provided in N. J. S. 18A:28-12.

In Corrado v. Board of Education of the Borough of Newfield, Glowcester County, 1984 S. L. D. (Commissioner of Education 1984), the Commissioner of Education held that N. J. S. 18A:28-12 grants military service credit to teachers who were required to serve in the armed forces after September 1, 1940, provided they previously enjoyed a tenure status in the Board of Education's employ which was subsequently interrupted by being called into the armed forces. Therefore, under this interpretation of the law, the military service credit applies upon the resumption of employment by the board, after termination from military service, of tenured teaching staff members who were employed by the board

after September 1, 1940 and were subsequently called into the armed forces.

All teachers who are veterans and honored their military commitments had their lives disrupted and their careers delayed, if not interrupted, because of the time that they spent serving in the military. The purpose of this bill is to clarify the law to ensure that seniority entitlement is afforded to all veterans by recognizing all military service after September 1, 1940 even if it occurred prior to the time that the veteran was employed by the board. This bill would provide the same four years of credit for military service for seniority purposes as provided in the military service credit for salary purposes pursuant to N. J. S. 18A:29-11.

Governor Thomas H. Kean today signed legislation extending to October 30 the deadline for employers subject to the State's Worker and Community Right to Know Act to complete and submit detailed information on hazardous substances to appropriate State agencies.

The legislation also extends to October 30 the deadline for the employers to establish employee training programs in the handling of hazardous substances and to label such substances.

The legislation,  $\underline{S-3142}$ , was sponsored by Senator Daniel Dalton, D-Camden.

Other bills signed by Kean are:

S-2537, sponsored by Senator Francis McManimon, D-Mercer, to appropriate \$200,000 for the construction of a new gymnasium at the Jamesburg Training School.

A-3683, sponsored by Assemblyman Walter Kavanaugh, R-Somerset, to permit up to four years of credit for military service when computing seniority credit for teachers.
