An Act to amend the "Public School Education Act of 1975," approved September 29, 1975 (P. L. 1975, c. 212).

- 1 Be it enacted by the Senate and General Assembly of the State

- 1 Section 3 of P. L. 1975, c. 212 (C. 18A:7A-3) is amended to

"Approved special class pupil" means a pupil enrolled in any class for atypical pupils pursuant to chapter 46 of Title 18A of the

"Approved special education services pupil" means a pupil receiving specific services pursuant to chapter 46 of Title 18A of the New Jersey Statutes but excluding pupils attending county special services school districts.

32 "Bilingual education pupil" means a pupil enrolled in a program 33 of bilingual education approved by the State board.

34 "Budgeted capital outlay" means those capital outlay expendi-35 tures that are included in the annual school budget.

"Categorical programs" means those programs and services recognized in this act as requiring per pupil expenditures over and above those applicable to regular programs, as provided in section 20 of this act.

"Current expense" means all expenses of the school district, as enumerated in N. J. S. 18A:22-8, other than those required for interest and debt redemption charges and any budgeted capital project.

44 "Debt service" means and includes payments of principal and interest upon school bonds and other obligations issued to finance 45 46 the acquisition of school sites and the acquisition, construction or reconstruction of school buildings, including furnishings, equip-47 ment and the costs of issuance of such obligations and shall include 48 payments of principal and interest upon bonds heretofore issued to 49 **5**0 fund or refund such obligations, and upon municipal bonds and other obligations which the commissioner approves as having been 51issued for such purposes. Debt service pursuant to the provisions 5253 of P. L. 1971, c. 10 (C. 18A:58-33.6 et seq.) and P. L. 1968, c. 177 [(C. 18A:33.2 et seq.)] (C. 18A:58-33.2 et seq.) is excluded. 54

"District equalized valuation per pupil" means the quotient resulting from dividing the total equalized valuations in the school district by the resident enrollment of the district; provided that in the determination of the equalized valuation per pupil of a county vocational school the total equalized valuations in the county shall be divided by the total resident enrollment in all school districts of the county to obtain the county vocational school equalized valuation per pupil.

63 "Equalized valuations" means the equalized valuation of the 64 taxing district or taxing districts as certified by the Director of the 65 Division of Taxation on October 1 of the [prebudgeted] prebudget 66 year.

- With respect to regional districts and their constituent districts,

"Objective" means a written statement of the intended outcome 110 of a specific educational process.

"Prebudget year" means the school year preceding the year in the school budget will be implemented.

"Resident enrollment" means the number of pupils who are resi114 dent of the district and are enrolled in day or approved evening
115 schools on the last school day of September of the prebudget year
116 and are attending: (1) the public schools of the district; (2) another
117 school district or a State college demonstration school to which the
118 district of residence pays tuition; or (3) a State facility; provided
119 that a district shall count pupils regularly attending both the
120 schools of the district and of a county vocational school in the

"Standards" means the process and stated levels of proficiency 127 used in determining the extent to which goals and objectives are 128 being met.

"State average net current expense budget per pupil" means 130 the quotient resulting from dividing the total net current expense 131 budget of all districts in the State by the total resident enrollment 132 in the State.

133 "State average valuation per pupil" means the quotient result-134 ing from dividing the total equalized valuations in the State as 135 certified by the Director of the Division of Taxation on October 1 136 by the total resident enrollment in the State. In the event that the 137 equalized table certified by the Director of the Division of Taxation 138 shall be revised by the tax court on or before January 30 of the 139 next succeeding year, such revised valuation shall be used in any 140 recomputation of aid for an individual district filing such appeal 141 but will have no effect upon the State average valuation per pupil. "State compensatory education pupil" means a pupil who is en-143 rolled in preventive and remedial programs offered during the 144 normal school day, or in programs offered beyond the normal school 145 day or during summer vacation, which are integrated and co-146 ordinated with programs operated during the regular school day 147 and year. Said programs shall be approved by the State board, 148 supplemental to the regular programs and designed to assist pupils 149 who have academic, social, economic or environmental needs that 150 prevent them from succeeding in regular school programs.

151 "State facility" means a State residential facility for the

152 retarded; a day training center which is operated by or under 153 contract with the State and in which all the children have been 154 placed by the State; a State residential youth center; a State train-155 ing school or correctional facility; a State child treatment center 156 or psychiatric hospital.

157 "State support limit" means the sixty-fifth percentile net current 158 expense budget per pupil for the prebudget year when all district 159 figures are ranked from low to high. The State support limit shall 160 be calculated and applied separately for (a) limited purpose re-161 gional districts offering grades nine through 12, (b) limited pur-162 pose regional districts offering grades seven through 12, provided, 163 however, that the figure used for such districts shall be not less 164 than 90% of the sixty-fifth percentile for limited purpose regional 165 districts offering grades nine through 12, (c) constitutent districts 166 of limited purpose regional districts offering grades nine through 167 12, (d) constituent districts of limited purpose regional districts 168 offering grades seven through 12, provided, however, that the figure 169 used for such districts shall be not less than 90% of the sixty-fifth 170 percentile for constituent districts of limited purpose regional dis-171 tricts offering grades nine through 12, and (e) all other districts.

1 2. Section 25 of P. L. 1975, c. 212 (C. 18A:7A-25) is amended 2 to read as follows:

3 25. A district which has [a] an adjusted net current expense 4 budget per pupil in the prebudget year of less than the adjusted 5 State average net current expense budget per pupil may increase its adjusted net current expense budget per pupil in the following 6 7 year by no more than an amount found by multiplying three-fourths 8 of the latest annual percentage increase in the total State equalized 9 valuation by the adjusted State average net current expense budget per pupil for the prebudget year, and multiplying the product by 10 11 the quotient resulting from dividing the adjusted State average net current expense budget per pupil by the school district adjusted 12net current expense budget per pupil for the prebudget year. Any 13 other district may increase its adjusted net current expense budget 14per pupil by no more than an amount found by multiplying three-15fourths of the latest annual percentage increase in the total State 16 equalized valuation by the school district's adjusted net current 17 expense budget per pupil for the prebudget year, and multiplying 18 19 the product by the quotient resulting from dividing the adjusted State average net current expense budget per pupil by the school 20district's adjusted net current expense budget per pupil for the 21prebudget year. For the purpose of these calculations, the enroll-22 ment of a district shall be assumed to remain constant between the

24 prebudget year and the year during which the budget will be 25 implemented and the figure used for the latest annual percentage 26increase in the total State equalized valuation shall not be less 27 than the average of such percentage increases for the latest three 28 vears. 29 For the purposes of this section, the *adjusted* State average 30 net current expense budget per pupil shall be calculated and ap-31 plied separately for (a) limited purpose regional districts offering 32 grades nine through 12, (b) limited purpose regional districts offer-33 ing grades seven through 12; provided, however, that the figure 34 used for such district shall not be less than 90% of the *adjusted* 35 State average net current expense budget per pupil for limited 36 purpose regional districts offering grades nine through 12, and (c) county vocational schools. For all other districts, the *adjusted* 37 38 State average net current expense budget per pupil shall be calculated pursuant to section 3 of P. L. 1975, c. 212 (C. 18A:7A-3). 39 Annually, on or before November 15, the commissioner shall 40 certify to each local board of education the amount by which the 41 42school district may increase its budget for the next year without exceeding the permissible rate of increase. 43 44 The commissioner may approve the request of a local board of education for a greater increase, having adjudged that (1) a 45 reallocation of resources or any other action taken within the 46permissible level of spending would be insufficient to meet the 47 48 goals, objectives and standards established pursuant to this act, or (2) an increased enrollment may reasonably be anticipated in the 49 50 district. 51 Nothing in this section shall prevent a board of education from appropriating additional amounts from miscellaneous revenues or 52 free balances during the budget year* , however, such increases 53 shall not be included in the calculation of the increase in the ad-54 justed net current expense budget per pupil for the following 55

DATED: APRIL 30, 1984

This bill provides for the inclusion of budgeted free balances (surplus) and miscellaneous revenue in the calculation of school district budget caps for the following year. Cap allowances would be computed as they presently are but would be based on the district's adjusted net current expense budget (ANCEB) per pupil after including these two items, rather than the net current expense budget (NCEB) per pupil as is presently the case.

The bill also makes clear that appropriations from surplus or miscellaneous revenue made during the school year, but after the budget is approved, shall not be included in the cap calculation for the following year.

FISCAL IMPACT

State school aid is based on district NCEB's. This bill does not change the definition of NCEB or the calculation of State aid. However, to the extent that cap leeways are changed, district NCEB's in the year following the budgeting of surplus revenues could be higher or lower than might otherwise be the case.

The Department of Education estimates a maximum increase in State aid of \$2 million which would not become payable until fiscal year 1986-87 at the earliest.

PRIOR LEGISLATION

Senate Bill No. 476 of 1982 was released by the Senate Education Committee and referred to this committee.

Provisions:

This bill provides for the inclusion of appropriated surplus in the calculation of the budget caps for the following year. At present, any appropriated surplus is not included in the net current expense budget (NCEB). Since the cap is essentially the permissible increase in the NCEB, the use of surplus results in a more restrictive cap the following year.

Any unbudgeted surplus could be appropriated by a board during the budget year, however, this would not be included in the cap calculation for the following year.

PRIOR ACTION:

During the 1982-83 session the Senate Education Committee favorably released this bill (Senate Bill No. 476) with the recommendation that it be referred to the Senate Revenue, Finance and Appropriations Committee for a fiscal analysis. No action was taken by that committee.

COMMITTEE AMENDMENTS

The committee amendments are technical in nature.

Governor Thomas H. Kean has signed legislation which authorizes the Child Support Unit in the Department of Human Services to obtain income executions on unemployment insurance benefits to enforce child support orders.

The bill, $\underline{S-1972}$, was sponsored by State Senator Donald T. DiFrancesco, R-Union. It brings New Jersey statutes into compliance with Federal law governing child support.

The Governor also signed the following bills:

<u>S-596</u>, sponsored by State Senator S. Thomas Gagliano, R-Monmouth, which directs local school districts to establish policies which would allow military recruiters the same access to school facilities as is provided to educational and occupational recruiters.

<u>S-534</u>, sponsored by State Senator Wayne Dumont, Jr., R-Warren, which provides for the inclusion of budgeted free balances (surplus) and miscellaneous revenue in the calculation of school district budget caps. Under the bill, cap allowances would be computed as they currently are, but would be based on the district's adjusted net current expense budget per pupil after including the surplus and miscellaneous revenue.

<u>S-1306</u>, sponsored by State Senator Joseph Hirkala, D-Passaic, which provides that a housing police officer shall, under certain circumstances, have all the powers conferred by the law on police officers, so long as the housing police officer has completed full training as required by the Police Training Commission, and qualifies annually in the use of a weapon.
