An Acr establishing a program for the voluntary fingerprinting of certain school children.

- 1 Be it enacted by the Senate and General Assembly of the State

- 1 2. a. Public school officials shall cooperate with sheriffs and local
- 2 law enforcement officials in setting dates for fingerprinting pupils
- 3 pursuant to this act and providing school facilities and personnel
- 4 to assist in the fingerprinting process.
- 5 b. No pupil shall be fingerprinted unless the signed authorization
- 6 section of the fingerprint card is completed by the student's parent
- 7 or guardian \*\*or temporary caretaker\*\*.
- 8 c. School officials shall notify the parents or guardians \*\*or
- 9 temporary caretakers\*\* of eligible pupils of the date set for the

This bill with minor amendments is identical to Senate Bill No. 1093, which was released by the committee on May 21, 1984.

Governor Thomas H. Kean today signed legislation establishing a voluntary fingerprinting program for children in the kindergarten through ninth grades. Under the terms of the bill, county sheriffs would work with local police and school officials to produce fingerprint cards which would become the exclusive property of the child's parent or guardian.

The bill,  $\underline{\text{A-319}}$ , was sponsored by Assemblywoman Angela L. Perun, R-Union.

The intent of the bill is to provide parents who want it, a fingerprint record of their child for use in aiding authorities should the child become missing.

"Every one of us has been horrified by the flood of stories and statistics on missing and abused children," Kean said. "Every one of these stories is a black mark against our way of life and our hopes. Because the children of this nation are this nation's life and hope."

The Governor noted that the bill makes specific provisions for the fingerprint cards to be the exclusive property of parents or guardians. He also stressed that the program is completely voluntary.

"We are very conscious of not infringing on a child's rights or privacy in our efforts to protect New Jersey's children," Kean said. "This law absolutely forbids either the sheriff's office or local law enforcement officials to keep any prints of the children.

The Governor also said that schools will be asked to provide orientation programs before the program begins so that children will not be intimidated or frightened by having their finger prints takens.

"If we can provide any help to identify the missing --- to end the anguish of the people who love them --- we have a duty to hold out that helping hand," Kean said. "This is most pressingly and undeniably true in the case of children who need help in protecting themselves. If holding out that helping hand means taking the hand of a child, and recording his or her unique print, then that's what we will do."
