STATEMENT

Some older residents of New Jersey are unaware of all existing State programs and services from which they may benefit. In addition, there are State laws and regulations concerning tenants' rights, nursing homes, inheritance taxes, and other matters which are of particular importance to senior citizens.

This bill directs the Division on Aging in the Department of Community Affairs to prepare and distribute a directory of State programs and a compilation of State laws and regulations to ensure that senior citizens are aware of their rights and entitlements. The bill appropriated \$99,000.00 for the cost of printing and distributing this information.

This bill, as amended, directs the Department of Community Affairs through the State Division on Aging to prepare and distribute an information guide listing all senior citizen programs and services available from the State.

The committee amendments result in the following changes:

- (1) The method of preparing and distributing information to older persons will remain in the discretion of the Division on Aging;
- (2) Information provided shall be continually updated to ensure the most accurate and comprehensive information available;
- (3) The compilation of State laws and regulations affecting older persons in the State will not be legislatively mandated; and
- (4) The appropriation for the bill is reduced from \$99,000.00 to \$50,000.00.

The bill, as amended, was reported out favorably from the committee.

This bill directs the Division on Aging in the Department of Community Affairs to prepare and distribute, in a format selected by the division, information regarding State and federal programs which benefit older persons. On an ongoing basis, the division will evaluate the need to update the information.

The bill contains an appropration of \$50,000.00 from the General Fund.

A-3463, sponsored by Assemblyman Thomas H. Paterniti, D-Middlesex, which directs the Division on Aging to prepare and distribute information regarding State and Federal programs which benefit older persons.

A-3488, sponsored by Assemblyman Joseph L. Bocchini, D-Mercer, which permits a person who files a statement of claim with an insurance company to verify the services rendered by certification, rather than under oath.

S-2164, sponsored by Senate President Carmen A. Orechio, D-Essex, which extends State Police Retirement System (SPRS) survivors benefits to widows who married SPRS members age 55 or older, and to all widowers. The current law limited benefits to widows who married before the member turned 55, and to children and parents of the deceased.
