AN ACT concerning membership in the Police and Firemen's Retirement System of New Jersey and amending and supplementing P. L. 1944, c. 255.

- 1 BE IT ENACTED by the Senate and General Assembly of the State
- 2 of New Jersey:

1 1. Section 1 of P. L. 1944, c. 255 (C. 43:16A-1) is amended to 2 read as follows:

3 1. As used in this act:

(1) "Retirement system" shall mean the Police and Firemen's 4 Retirement System of New Jersey as defined in section 2 of this act. 5 (2) "Policeman or fireman" shall mean any permanent and full-6 time active uniformed employee, and any active permanent and 7full-time employee who is a detective, lineman, fire alarm operator. 8 9 or inspector of combustibles of any police or fire department or any employee of a police or fire department who was a member 10of the retirement system for a period of 15 years prior to his trans-11 12fer to a position within the department not otherwise covered by the retirement system. It shall also mean any permanent, active, 13and full-time firefighter or officer employee of the State of New 14 Jersey, or any political subdivision thereof, with police powers and 15holding one of the following titles: motor vehicles officer, motor 16 vehicles sergeant, motor vehicles lieutenant, motor vehicles captain, 17assistant chief, bureau of enforcement, and chief, bureau of enforce-18ment in the Division of Motor Vehicles, ** and highway patrol 19officer, sergeant highway patrol bureau, lieutenant highway patrol 20bureau, captain highway patrol bureau, assistant chief highway 2122patrol bureau, chief highway patrol bureau in the Division of State

66 (3) "Member" shall mean any policeman or fireman included
67 in the membership of the retirement system as provided in section
68 3 of this act.

(4) "Board of trustees" or "board" shall mean the board pro-vided for in section 13 of this act.

(5) "Medical board" shall mean the board of physicians pro-vided for in section 13 of this act.

(6) "Employer" shall mean the State of New Jersey, the county,
municipality or political subdivision thereof which pays the particular policeman or fireman.

(7) "Service" shall mean service as a policeman or fireman paidfor by an employer.

(8) "Creditable service" shall mean service rendered for whichcredit is allowed as provided under section 4 of this act.

80 (9) "Regular interest" shall mean interest as determined annu-81 ally by the State Treasurer after consultation with the Directors 82 of the Division of Investment and Pensions and the actuary of the 83 system. It shall bear a reasonable relationship to the percentage 84 rate of earnings on investments but shall not exceed 105% of such 85 percentage rate.

86 (10) "Aggregate contributions" shall mean the sum of all the 87 amounts, deducted from the compensation of a member or con-88 tributed by him or on his behalf, standing to the credit of his indi-89 vidual account in the annuity savings fund. 90 (11) "Annuity" shall mean payments for life derived from the91 aggregate contributions of a member.

92 (12) "Pension" shall mean payments for life derived from93 contributions by the employer.

94 (13) "Retirement allowance" shall mean the pension plus the 95 annuity.

96 (14) "Earnable compensation" shall mean the full rate of the 97 salary that would be payable to an employee if he worked the full 98 normal working time for his position. In cases where salary in-99 cludes maintenance, the retirement system shall fix the value of that 100 part of the salary not paid in money which shall be considered 101 under this act.

102 (15) "Average final compensation" shall mean the average 103 annual salary upon which contributions are made for the three years 104 of creditable service immediately preceding his retirement or death, 105 or it shall mean the average annual salary for which contributions 106 are made during any three fiscal years of his or her membership 107 providing the largest possible benefit to the member or his benefi-108 ciary.

109 .(16) "Retirement" shall mean the termination of the member's110 active service with a retirement allowance granted and paid under111 the provisions of this act.

112 (17) "Annuity reserve" shall mean the present value of all pay-113 ments to be made on account of any annuity or benefit in lieu of 114 any annuity computed upon the basis of such mortality tables 115 recommended by the actuary as shall be adopted by the board of 116 trustees, and regular interest.

117 (18) "Pension reserve" shall mean the present value of all pay-118 ments to be made on account of any pension or benefit in lieu of 119 any pension computed upon the basis of such mortality tables 120 recommended by the actuary as shall be adopted by the board of 121 trustees, and regular interest.

(19) "Actuarial equivalent" shall mean a benefit of equal value
when computed upon the basis of such mortality tables recommended by the actuary as shall be adopted by the board of trustees,
and regular interest.

126 (20) "Beneficiary" shall mean any person receiving a retire-127 ment allowance or other benefit as provided by this act.

128 (21) "Child" shall mean a deceased member's or retirant's un-129 married child either (a) under the age of 18 or (b) of any age 130 who, at the time of the member's or retirant's death, is disabled 131 because of mental retardation or physical incapacity, is unable to 132 do any substantial, gainful work because of the impairment and his

133 impairment has lasted or can be expected to last for a continuous 134 period of not less than 12 months, as affirmed by the medical board. 135 (22) "Parent" shall mean the parent of a member who was 136 receiving at least one-half of his support from the member in the 137 12-month period immediately preceding the member's death or the 138 accident which was the direct cause of the member's death. The 139 dependency of such a parent will be considered terminated by 140 marriage of the parent subsequent to the death of the member.

141 (23) "Widower" shall mean the man to whom a member or 142 retirant was married at least two years before the date of her 143 death and to whom she continued to be married until the date of her 144 death and who was receiving at least one-half of his support from 145 the member or retirant in the 12-month period immediately preced-146 ing the member's or retirant's death or the accident which was the 147 direct cause of the member's death. The dependency of such a 148 widower will be considered terminated by marriage of the widower 149 subsequent to the death of the member or retirant. In the event of 150 the payment of an accidental death benefit, the two-year qualifica-151 tion shall be waived.

(24) "Widow" shall mean the woman to whom a member or retirant was married at least two years before the date of his death and to whom he continued to be married until the date of his death back and who has not remarried. In the event of the payment of an accidental death benefit, the two-year qualification shall be waived. (25) "Fiscal year" shall mean any year commencing with July 1, and ending with June 30, next following.

(26) "Compensation" shall mean the base salary, for services as a member as defined in this act, which is in accordance with established salary policies of the member's employer for all emlez ployees in the same position but shall not include individual salary adjustments which are granted primarily in anticipation of the head member's retirement or additional remuneration for performing to temporary duties beyond the regular work day.

166 (27) "Department" shall mean any police or fire department of 167 a municipality or a fire department of a fire district located in a 168 township or a county police or park police department or the 169 appropriate department of the State or instrumentality thereof.

(28) "Final compensation" means the compensation received by171 the member in the last 12 months of creditable service preceding172 his retirement.

1 2. (New section) a. Any officer eligible to become a member pur-

2 suant to the amendatory provisions of this act who is enrolled in

3 the Public Employees' Retirement System (P. L. 1954, c. 84; C.

4 43:15A-1 et seq.) shall be permitted to transfer membership from $\mathbf{5}$ the aforesaid system to the Police and Firemen's Retirement Sys-6 tem of New Jersey in accordance with the provisions of P. L. 1973, 7 c. 156 (C. 43:16A-62 et seq.) and upon a lump sum payment into 8` the Police and Firemen's Retirement System annuity savings fund 9 in the amount of the difference between the contribution which was 10 paid as a member of the Public Employees' Retirement System and 11 the contribution that would have been required if he had been 12a member of the Police and Firemen's Retirement System since 13 the date of last enrolling in the Public Employees' Retirement 14 System. In addition, the employee shall be liable for ** [any pay-15ment to the retirement system that the employer would have been 16required to make on behalf of the member for the purchase of that 17 credit]** ** the amount of the difference between (1) the total contribution paid by the employer of the employee to the Public Em-18ployees' Retirement System with respect to any service credit 19 transferred therefrom to the Police and Firemen's Retirement 20System under this subsection, and (2) the contribution which the 2122employer would have been required to pay to the Police and Fire-23men's Retirement System with respect to that service credit if the 24employee had been enrolled in the Police and Firemen's Retirement 25System during the entire period with respect to which he accumu-26 lated that credit**; this payment may be made in regular monthly installments or in a lump sum, as the employee may elect, and 2728pursuant to rules and regulations as may be promulgated by the 29Division of Pensions.

Any such employee will likewise be permitted to continue his 30membership in the Public Employees' Retirement System by waiv-31 32ing all rights and benefits which would otherwise be provided by the Police and Firemen's Retirement System. A waiver to remain 3334 in the Public Employees' Retirement System or to transfer to the Police and Firemen's Retirement System shall be accomplished by 35 filing forms satisfactory to the Division of Pensions with the divi-3637 sion within 90 days after the effective date of this 1985 amendatory 38 and supplementary act. In the absence of filing a timely waiver and, if appropriate, making payment to the Division of Pensions, 39 40 an eligible officer or employee's pension status shall remain unchanged and his membership shall not be transferred to the police 41 42and Firemen's Retirement System.

Whenever in P. L. 1973, c. 156 a period of time is set which is
to be calculated from the effective date of that act, the time shall



This bill deletes unused titles and adds new titles in the Bureau of Forest Fire Management, Department of Environmental Protection to the titles presently set forth in the membership eligibility section of the Police and Firemen's Retirement System law to provide for lateral title changes recently approved by the Department of Civil Service for persons already in the Police and Firemen's Retirement System, with the exception of one employee who previously was in a nonapproved title and has been moved to an approved title.

The bill provides that a transferring member shall pay both the employee and the employer costs. It was amended to conform to the latest version of the law. (

ASSEMBLY BILL NO. 3164 (OCR)

To the General Assembly:

Pursuant to Article V, Section 1, Paragraph 14 of the Constitution, I herewith return Assembly Bill No. 3164 (OCR) with my recommendations for reconsideration.

Assembly Bill No. 3164 (OCR) amends the law pertaining to the Police and Firemen's Retirement System (PFRS) to include new Civil Service job titles. The titles are Supervising Forest Fire Warden, Division Forest Fire Warden, Assistant Division Forest Fire Warden and Section Forest Fire Warden. Most of the individuals occupying these positions were in the PFRS prior to obtaining new job classifications. Assembly Bill No. 3164 (OCR) ensures that these individuals will remain in the PFRS.

Assembly Bill No. 3164 (OCR) also allows employees in the above Civil Service job titles who are not currently in the PFRS to transfer to the PFRS. A transferring employee will pay his and his employer's portions of the pension transfer cost.

I support the concepts expressed within Assembly Bill No. 3164 (OCR). The bill will ensure that employees who have always been PFRS members will not lose their status simply because they have received job titles that are not contained within the law pertaining to the PFRS. The bill will also allow individuals occupying the new job titles who are not members of the PFRS an opportunity to obtain the same pension benefits as their colleagues.

Despite my support for the concepts expressed within Assembly Bill No. 3164 (OCR), I must return the bill so that section 2, pertaining to transfer to the PFRS, may be amended in three areas and to incorporate recent changes made to this area of the law.

Section 2 must be amended to ensure that the transferring employee will pay the employer's portion of the pension transfer cost. The section requires the transferring employee to pay the employer's portion of the cost of a purchase of service credit; not a transfer of service credit. The Division of Pensions advises that in its current form, section 2 would not obligate a

transferring employee to pay the employer's portion of the pension transfer cost. I recommend that the section be amended to delete all reference to a purchase of service credit and to insert reference to a transfer of service credit. I also recommend that the language pertaining to the employee's obligation to pay the employer's portion of the cost be amended to redefine and to describe the cost.

Section 2 must be amended to clarify that transfer to the PFRS will not be mandatory for employees currently working in the new Civil Service job titles. Section 2 is unclear in this regard.

Section 2 must be amended to set a deadline on an employee's option to file notice of his intent to transfer to the PFRS, with the Division of Pensions. I recommend that an eligible employee be required to file a notice of transfer within 90 days of the effective date of this act.

Finally, I recommend that several technical amendments be made to incorporate the changes made in this area of the law by chapters 221 and 262 of the laws of 1985.

Accordingly, I return Assembly Bill No. 3164 (OCR) and recommend that it be amended as follows:

Page 1, Section 1, Line 19: After "Vehicles," insert "and highway patrol officer, sergeant highway patrol bureau, lieutenant highway patrol bureau, captain highway patrol bureau, assistant chief highway patrol bureau, chief highway patrol bureau in the Division of State Police and"

<u>Page 1, Section 1, Line 22</u>: After "Control," insert "and inspector recruit alcoholic beverage control, inspector alcoholic beverage control, senior inspector alcoholic beverage control, principal inspector alcoholic beverage control, supervising inspector alcoholic beverage control in the Division of State Police and"

<u>Page 2, Section 1, Line 35</u>: After "Protection," insert "and marine police officer, senior marine police officer, principal marine police officer in the Division of State Police, and"

Page 2, Section 1, Line 37: After "enforcement," insert "and"
Page 2, Section 1, Line 39: After "chief" omit ","
Page 2, Section 1, Line 61: After first "officer," insert "and"

<u>Page 5, Section 2, Lines 14-17</u>: Delete "any payment" on line 14 and delete lines 15-16 in their entirety and delete "credit" on line 17 and insert "the amount of the difference between (1) the total contribution paid by the employer of the employee to the Public Employees' Retirement System with respect to any service credit transferred therefrom to the Police and Firemen's Retirement System under this subsection, and (2) the contribution which the employer would have been required to pay to the Police and Firemen's Retirement System with respect to that service credit if the employee had been enrolled in the Police and Firemen's Retirement System during the entire period with respect to which he accumulated that credit"

Page 5, Section 2, After Line 19: Insert new paragraph as follows:

"Any such employee will likewise be permitted to continue his membership in the Public Employees' Retirement System by waiving all rights and benefits which would otherwise be provided by the Police and Firemen's Retirement System. A waiver to remain in the Public Employees' Retirement System or to transfer to the Police and Firemen's Retirement System shall be accomplished by filing forms satisfactory to the Division of Pensions with the division within 90 days after the effective date of this 1985 amendatory and supplementary act. In the absence of filing a timely waiver and, if appropriate, making payment to the Division of Pensions, an eligible officer or employee's pension status shall remain unchanged and his membership shall not be transferred to the Police and Firemen's Retirement System."
