## STATE OF NEW JERSEY

**DATED: JUNE 20, 1985** 

This substitute bill provides that any municipal ordinance vacating any street, highway, lane, alley, square, place or park, or any part thereof, shall expressly reserve and except from vacation all rights and privileges possessed at the time of passage of the ordinance by public utilities to maintain, repair and replace their existing utility facilities in, adjacent to, over or under the street, highway, lane, alley, square, place or park to be vacated. The purpose of the bill is to permit the public utilities to maintain their rights in these matters and to put a possible owner or developer of the property to be vacated on notice that these rights are preserved in the vacation ordinance. Cable television facilities are also included in the bill.

Senate Bill No. 2797 and Assembly Bill No. 2108 (which are identical) provide for 15 days' written notice to the public utilities prior to the introduction of any vacation ordinance. It was felt that such written notice was not feasible since municipal governing bodies may not always have 15 days' notice of ordinances to be introduced.
