- An Act concerning the access of *minorities and* women to technical training and supplementing Title 18A of the New Jersey Statutes.
- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:

STATEMENT

This bill, the "Technical Training for Women Act," requires the Departments of Education and Labor to take actions to increase the rate of female participation in apprenticeship and other training programs for technical trades. The Commissioners of Education and Labor are required to report annually to the Legislature on the nature and success of their efforts pursuant to this act.

COMMITTEE AMENDMENTS:
