Senate Bill No. 1390, as amended by the Senate Law, Public Safety and Defense Committee, permits an active member or honorably retired member of the New Jersey National Guard who is so certified by the New Jersey Department of Defense to affix a special "Minuteman" emblem to his National Guard license plates.

The bill authorizes the Director of the Division of Motor Vehicles and the head of the New Jersey Department of Defense to promulgate regulations regarding the design and affixation of the emblem and regarding surrender of the emblem by a person no longer qualified to display it.

The committee amended the bill to conform it to section 34 of P. L. 1984, c. 181, which changes the title of the Chief of Staff of the New Jersey Department of Defense to Adjutant General.

Senate Bill No. 1390 permits an active member or an honorably retired member of the New Jersey National Guard to affix a special "Minuteman" emblem to his National Guard license plates.

The bill authorizes the Director of the Division of Motor Vehicles and the head of the New Jersey Department of Defense to promulgate regulations regarding the design and affixation of the emblem and regarding the surrender of the emblem by a person no longer qualified to display it.

SENATE BILL NO. 1390 (OCR)

To the Senate:

Pursuant to Article V, Section I, Paragraph 14 of the Constitution, I herewith return Senate Bill No. 1390 (OCR) with my recommendations for reconsideration.

This bill would allow current or former members of the National Guard to affix a National Guard Minuteman emblem to their automobile license plates. A former member of the Guard would have to have been honorably separated from the National Guard as certified by the Adjutant General in the Department of Defense. The Director of the Division of Motor Vehicles and the Adjutant General would promulgate rules and regulations governing the design and affixation of the National Guard Minuteman emblems.

I appreciate all of the fine work done by the National Guard and would like to commend the men and women who give of their time and effort in helping to protect New Jersey during emergencies and serving as a trained corps of military personnel in the event of warfare.

However, I believe that the attachment of special emblems to license plates should be limited to those persons who currently serve in the capacity indicated by the affixed emblem. Therefore, it is my recommendation that only current members of the National Guard be allowed to attach these Minuteman emblems to their license plates.

Therefore, I herewith return Senate Bill No. 1390 (OCR) and recommend that it be amended as follows:

Page 1, Section 1, Line 14: Delete "holders of" insert "any person who is an active member of the New Jersey

National Guard with"

Governor Thomas H. Kean has signed the following bills:

S-45, sponsored by State Senator Laurence S. Weiss, D-Middlesex, which excludes from taxation the interest on indebtedness of a banking corporation to another banking corporation when both corporations are subsidiaries of the same bank holding corporation.

The bill was conditionally vetoed to limit application to Federal funds transactions and to make technical changes.

S-891, sponsored by State Senator James R. Hurley, R-Cumberland, which allows a member of the Teachers Pension and Annuity Fund to purchase credit for prior service in a school outside the United States. The school must be operated by a department of the United States Government for the instruction of children of United States Governmental officers and employees.

S-990, sponsored by State Senator Daniel J. Dalton, D-Camden, which exempts small landfills from the auditing requirements of the Sanitary Landfill Facility Closure and Contingency Fund Act. The bill applies to landfills accepting less than 10,000 tons of solid waste per year or whose escrow account balance is not in excess of \$100,000.

S-1390, sponsored by State Senator Walter E. Foran, R-Hunterdon, which permits members of the New Jersey National Guard to affix a National Guard Minuteman emblem to their auto license plate. The bill was conditionally vetoed to remove former Guardsmen from the bill.
