

An Act concerning the training of policemen and amending *and supplementing* P. L. 1961, c. 56.

- 1 Be it enacted by the Senate and General Assembly of the State

STATEMENT

This bill makes several changes in the law concerning police training. In section 1, special investigators of the county prosecutor have been deleted from the exceptions to the definition of police officer. The effect of this amendment will be that special investigators will undergo training pursuant to the law concerning police training. Specifically, they will receive the same training that county detectives currently receive under the law. The job duties and responsibilities of a county detective and special investigator of the prosecutor are virtually identical. It is intended that training be required only for special investigators appointed to the position after the effective date of this act.

Section 2 amends the membership of the Police Training Commission to add the President of the County Prosecutors' Association of New Jersey or his designated representative and the President of the Sheriffs' Association of New Jersey or his designated representative. This amendment is made in recognition of the interest which county prosecutors and sheriffs have in law enforcement.

In view of the fact that the staff of the Police Training Commission are employees of the Department of Law and Public Safety

which is headed by the Attorney General, this bill recognizes the Attorney General's authority to employ persons as may be necessary to carry out the provisions of the law concerning police training within the limits of available appropriations. This change along with allocation of the commission to the Division of Criminal Justice will enable the Attorney General to consolidate manpower in this time of fiscal constraints.

Senate Bill No. 1764 includes county investigators in the office of the county prosecutor in the definition of "police officer." The effect of this amendment is that county investigators will receive the same training that county detectives now receive under the law. The duties and responsibilities of a county detective and a county investigator are virtually identical. The bill is intended to require training only of county investigators appointed after the date on which this bill takes effect.

The bill also adds the President of the County Prosecutors' Association of New Jersey or his designated representative and the President of the Sheriffs' Association of New Jersey or his designated representative to the membership of the Police Training Commission.

Finally, the bill empowers the Attorney General to appoint an administrator of police services with the advice and consent of the Police Training Commission and to employ other persons to carry out the provisions of law concerning police training. The bill also allocates the Police Training Commission to the Division of Criminal Justice within the Department of Law and Public Safety while ensuring that the civil service status and other rights of the existing employees of the commission are not affected by the transfer.

The Assembly Law, Public Safety and Defense Committee amended the bill to change the title of the executive secretary of the Police Training Commission to administrator of police services. Additional amendments conform the bill to current law.

Senate Bill No. 1764, as amended by the Senate Law, Public Safety and Defense Committee, makes several changes in the law concerning the training of police officers and the Police Training Commission.

The bill includes county investigators in the office of the county prosecutor in the definition of "police officer." The effect of this amendment is that county investigators will receive the same training that county detectives now receive under the law. The duties and responsibilities of a county detective and a county investigator are virtually identical. The bill is intended to require training only of county investigators appointed after the date on which this bill takes effect.

The bill also adds the President of the County Prosecutor's Association of New Jersey or his designated representative and the President of the Sheriffs' Association of New Jersey or his designated representative to the membership of the Police Training Commission.

Finally, the bill removes the Police Training Commission's power to appoint an executive secretary and to employ other persons to carry out the provisions of law concerning police training and, instead, gives the power to employ persons and fix their compensation within the limits of available appropriations to the Attorney General. The committee amended the bill to require the Attorney General to obtain the advice and consent of the Police Training Commission before appointing an executive secretary. The bill also allocates the Police Training Commission to the Division of Criminal Justice within the Department of Law and Public Safety. According to the sponsor's statement, these changes are intended to allow the Attorney General to consolidate manpower in a time of fiscal restraint.

The committee also amended the bill to ensure that the civil service status and other rights of existing employees of the Police Training Commission are not affected by the transfer of these employees to the Division of Criminal Justice.

S-1764, sponsored by Senator John Russo, D-Ocean, which places the Police Training Commission within the Department of Law and Public Safety, includes special investigators in county prosecutors' offices within the training provisions, and adds the President of the County Prosecutors' Association and the President of the Sheriffs' Association of New Jersey to the Commission membership.

S-2519, sponsored by Senator Frank Graves, D-Passaic, to enable a processor of goods to assert a lien over goods in his possession on the basis of prior indebtedness or of credit issued to the owner of the goods.

S-2907, sponsored by Senator Edward O'Connor, D-Hudson, to establish the Vietnam Veterans' Memorial Committee of 14 members to select a design and a site for a memorial in honor of Vietnam veterans.

S-3150, sponsored by Senator John Russo, D-Ocean, to require that any out of state veterinarian to be eligible for licensing in New Jersey under a reciprocity agreement to have practiced clinical veterinary medicine for three consecutive years prior to application for the license.

S-3330, sponsored by Senator Wynona Lipman, D-Essex, to extend to January 1, 1988, the authority of the City of Newark to impose a payroll and parking tax and for Jersey City to impose a parking tax.

<u>S-3424</u>, sponsored by Senator Paul Contillo, D-Bergen, to appropriate \$15,000 to the Department of Environmental Protection to reimburse the Borough of Maywood for expenses incurred in employing an environmental health physicist to aid in resolving a thorium contamination problem.

S-3438, sponsored by Senator Carmen Orechio, D-Essex, to transfer Certain responsibilities from the legislative counsel in the Office of Legislative Services to the New Jersey Law Revision Commission.
