INTRODUCED JANUARY 28, 1985

By Assemblymen THOMPSON and BROWN

An Act concerning the permitted use of additional hazard lights on omnibuses and amending R. S. 39:3-54.

- 1 Be it enacted by the Senate and General Assembly of the State

Assembly Bill No. 3188 pemits omnibuses to be equipped with special warning lights, sometimes referred to as "hijack lights," for the purpose of warning others that a robbery, hijacking, or other emergency situation exists. "Omnibus" is defined in R. S. 39:1-1 as ". . . all motor vehicles used for the transportation of passengers for hire, except commuter vans and vehicles used in ride-sharing arrangements and school buses if the same are not otherwise used in the transportation of passengers for hire."

Presently, the law prohibits fishing lights on motor vehicles except for turn signals and the emergency flashers which are standard equipment.

Permitting motor vehicles which carry passengers for hire, and thus become targets of robbery, to be equipped with these special devices should help reduce the number of crimes committed against drivers of omnibuses.

The Senate Law, Public Safety and Defense Committee favorably reports Assembly Bill No. 3188.

Assembly Bill No. 3188 permits onuibuses to be equipped with special warning lights, sometimes referred to as "hijack lights," for the purpose of warning the operators of other vehicles and law enforcement officials that an emergency, such as a robbery, is taking place inside the omnibus. The special warning lights permitted by the bill are flashing, red lights, capable of being activated by the operator, that shine on the roadway under the vehicle. The bill permits the Director of the Division of Motor Vehicles to approve the type of lights permitted by the bill.

"Omnibus" is defined in R. S. 39:1-1 as a motor vehicle "used for the transportation of passengers for hire, except commuter vans and vehicles used in ride-sharing arrangements and school buses if the same are not otherwise used in the transportation of passengers for hire."

Current law prohibits flashing lights on motor vehicles except for turn signals and the emergency flashers which are standard equipment.

The purpose of the bill is to aid in the reduction of crimes committed against drivers of omnibuses.

A-3188, sponsored by Assemblyman Eugene Thompson, D-Essex, to permit omnibuses to be equipped with flashing lights to warn others that an emergency exists on the vehicle.
