AN ACT permitting the permanent appointment of certain persons to the position of sheriff's officer without having to take the civil service examination in ***[any county]*** **certain counties**.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. In any county, **other than a county of the first class with a*
2 *population in excess of 850,000, according to the latest federal de-*
3 *cennial census,** a person who, on the effective date of this act,
4 is employed in the position of sheriff's officer as a provisional em-
5 ployee, and who has successfully completed a certified Police Acad-
6 emy Training Course in the State of New Jersey, is eligible for
7 permanent appointment by the sheriff to the position of sheriff's
8 officer without having to take the civil service open competitive
9 examination.

1 2. This act shall take effect immediately.

AN ACT permitting the permanent appointment of certain persons to the position of sheriff's officer without having to take the civil service examination in any county.

1 BE IT ENACTED *by the Senate and General Assembly of the State*
2 *of New Jersey:*

1 1. In any county, a person who, on the effective date of this act,
2 is employed in the position of sheriff's officer as a provisional em-
3 ployee, and who has successfully completed a certified Police Acad-
4 emy Training Course in the State of New Jersey, is eligible for
5 permanent appointment by the sheriff to the position of sheriff's
6 officer without having to take the civil service open competitive
7 examination.

1 2. This act shall take effect immediately.

STATEMENT

This bill permits the appointment of a provisional sheriff's officer to a permanent position without the officer taking a civil service open competitive examination, provided that such officer has successfully completed a certified Police Academy Training Course in this State.
