# STATE OF NEW JERSEY

### INTRODUCED MARCH 20, 1984

### By Assemblymen HAYTAIAN and LITTELL

An Act concerning boards of education of county vocationaltechnical schools in certain counties, supplementing chapter 54 of Title 18A of the New Jersey Statutes and repealing P. L. 1977, c. 30.

- BE IT ENACTED by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. Notwithstanding any provision of chapter 54 of Title 18A of
- 2 the New Jersey Statutes to the contrary, in all counties of the
- 3 third class with a population greater than 80,000 but less than
- 4 105,000 as of the latest federal decennial census the board of
- 5 education of the county vocational-technical school shall consist
- 6 of at least five members to be appointed by the appointing authority

- 1 2. The board members elected pursuant to section 1 of P. L. 1977,

### Provisions:

This bill establishes an appointed school board for counties of the third class with a population greater than 80,000 but less than 105,000 and requires school budgets in such counties to be approved by the county board of school estimate. In addition, this bill repeals P. L. 1977, c. 30 (C. 18A:54–16.1 et seq.) that provides for school elections, school budgets and the issuance of school bonds by county vocational school districts in certain counties.

#### BACKGROUND:

This bill is similar to P. L. 1983, c. 396 (C. 18A:54–16.8 et seq.) which had the effect of removing Sussex county from the provisions of the 1977 law that established elected school boards and budget referenda for both Sussex and Warren County Vocational School districts.

This bill repeals the 1977 law, removing the elected board and budget referendum from the only remaining county vocational-technical school affected by the 1977 law, Warren County Vocational-Technical School District, and replaces the elected board and budget referendum with an appointed board and a budget approved by the county board of school estimate.

DATED: JULY 30, 1984

This bill establishes an appointed school board for the Warren County Vocational Technical School and requires that the school budget be approved by the county board of school estimate.

It also repeals P. L. 1977, c. 30 (C. 18A:54-16.1 et seq.), which established an elected school board for the Warren and Sussex County Vocational Technical Schools.

The 1977 statute made Warren and Sussex counties the only counties with an elected county vocational school board. In 1983, Sussex county returned to an appointed board (P. L. 1983, c. 396 (C. 18:54–16.8 et seq.)).

This bill is identical to Senate Bill No. 1275.
