This bill eliminates the fee of \$15.00 now charged to former prisoners of war for special license plates.

United States and was held as a prisoner of war by an enemy of the United States as certified by the Division of Veterans' Programs and Special Services, State Department of Human Services, can apply to the Division of Motor Vehicles for a special license plate bearing the letters "P.O.W." In addition to regular motor vehicle registration fees, the person receiving the special plate must pay a fee of \$15.00 (P. L. 1981, c. 236; C. 39:3–27.24). The revenue collected from these fees is appropriated to the Division of Motor Vehicles to fund the additional costs incurred in making the plates available (P. L. 1981, c. 236; C. 39:3–27.26).

This bill eliminates the fee of \$15.00, making the special license plates for former prisoners of war available free of charge to those qualified to receive them. The bill also repeals the statute that appropriates the fees to the Division of Motor Vehicles.

Assembly Bill No. 782, of 1982, would eliminate the \$15.00 cost of special license plates for applicants who served in the U. S. Armed Forces and who were held as a prisoner of war by an enemy.

The Division of Motor Vehicles estimates a one time revenue loss and expense of \$51,000.00 (This is based on the approximately 3,000 former POWs in New Jersey all taking advantage of this legislation if enacted.)

The Office of Legislative Services concurs.

Governor Thomas H. Kean today signed the following lesiglation into law:

A-782, sponsored by Assemblyman J. P. Doyle (D-Ocean), omits the \$15.00 fee charged by the Division of Motor Vehicles for applicants eligible for the special "POW" license plates. Those plates will be issued with no special charge, effective immediately.

<u>S-979</u>, sponsored by Senator Wayne Dumont (R-Warren-Sussex), allows any former full-time, fully-trained and qualified police officer to be eligible for appointment as a special police officer.

S-764, sponsored by former Senator Steven Perskie (D-Atlantic), amends the Condominium Act to provide for any management contract to expire within 90 days after the first meeting of a governing board on which the unit owners constitute a majority, unless of course, the management contract is ratified. The legislation intends to protect unit owners from long-term management contracts influenced by the developer. Once unit owners constitute more than 75 percent of the governing board, the current two-year limitation on management, employment service and maintenance contracts does not apply and the governing board is then able to renegotiate contracts or ratify current agreements.
