An Act concerning lottery games and supplementing P. L. 1970, c. 13 (C. 5:9-1 et seq.).

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. Notwithstanding any other provision of law to the contrary,
- 2 no lottery or type of lottery or lottery game shall be authorized or
- 3 conducted which uses any *video* mechanical, electrical or other
- 4 *video* device, contrivance or machine which, upon the insertion
- 5 *by the participant* of a coin, token or similar object therein, or
- 6 upon payment of any consideration whatsoever, is available to play
- 7 or operate, the play or operation of which, whether by reason of
- 8 the skill of the operator or application of the element of chance, or
- 9 both, may deliver or entitle the person playing or operating the
- 10 machine to receive cash, tokens to be exchanged for cash, or any
- 11 other prize, whether the payoff is made automatically from the
- 12 machine or in any other manner whatsoever.
- 1 2. This act shall take effect immediately.

Governor Thomas H. Kean today signed S-1727, sponsored by State Senator Richard J. Codey, (D-Essex), which prohibits the use of video lottery machines by the Lottery Commission.

The Governor issued the following statement:

"The votes on this bill in both Houses of the Legislature indicate an extremely strong degree of support for the measure. The lottery is a vital source of revenue for our State, and for some of its most important programs, including our public schools, education for the deaf and programs for disabled veterans, the mentally retarded and the mentally ill.

"Thus it is critical that public perceptions of the operations of the lottery remain completely above reproach.

"Therefore, even though the video lottery could have raised additional money to support those programs, I have determined that continued public faith in the lottery requires that this bill become law."
