- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. In any county*, except a county of the first class,* any person
- 2 who on the effective date of this act is employed in the position of
- 3 sheriff's officer as a provisional employee, *[and who]* *who has
- 4 at least five years as a sworn police officer or has at least two
- 5 years experience as a provisional sheriff's officer, and who, prior
- 6 to July, 1982,* is enrolled in or who has successfully completed
- 7 a certified Police Academy Training Course in the State of New
- 8 Jersey, shall be eligible for permanent appointment by the sheriff*,
- 9 at his discretion,* to the position of sheriff's officer without having
- 10 to take the civil service open competitive examination*, upon

This bill would permit the sheriff of any county to appoint any person to the position of sheriff's officer on a permanent basis without requiring the person to take the civil service examination if, on the date the bill takes effect as law, the person holds the position of sheriff's officer in that county on a provisional basis and is enrolled in or has successfully completed a certified Police Academy Training Course in the State of New Jersey.

Assembly Bill No. 854 would permit the sheriff of certain counties to appoint certain provisional sheriff's officers to the position of sheriff's officer on a permanent basis without requiring the appointee to take an open competitive civil service examination.

The Senate committee amended the bill at the request of the sponsor to:

- 1. Exclude first class counties from the provisions of the bill;
- 2. Require that a provisional sheriff's officer pass a qualifying examination for the position prior to permanent appointment;
- 3. Require at least five years experience as a sworn police officer, or at least two years experience as a provisional sheriff's officer, to qualify for permanent appointment;
- 4. Require that a provisional sheriff's officer be enrolled in or successfully completed a certified Police Training Course prior to July, 1982, to qualify; and
- 5. Assure that the sheriff of the county may, in his discretion, permanently appoint qualifying provisional sheriff's officers.
