PRE-FILED FOR INTRODUCTION IN THE 1982 SESSION

By Senator ZANE

An Act concerning the regulation of the use and disposition of the bodies of dead animals; providing for the licensing of that business; authorizing the Department of Agriculture to promulgate rules and regulations therefor and providing penalties.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. a. "Department" means the Department of Agriculture.
- 2 b. "Disposal plant" means a place of business or the location
- 3 where the carcasses of domestic animals or meat packing house
- 4 refuse are: (1) received or unloaded; (2) processed for the purpose
- 5 of obtaining the hides, skin, grease residue, fertilizer, food for
- 6 animals or any other by-product in any manner; or (3) fed to hogs,
- 7 dogs, fur bearing or other animals, but shall not include an estab-
- 8 lishment inspected under the "Federal Meat Inspection Act" (21
- 9 U. S. C. 601 et seq.).
- 10 c. "Carcasses of domestic animals" means bodies or any part
- 11 thereof of dead livestock which are not intended for human food.
- 12 d. "Reportable disease" means diseases dangerous to animal
- 13 health as enumerated in regulations of the department adopted
- 14 under the authority of section 7 of P. L. 1950, c. 293 (C. 4:1-21.5).
- e. "Secretary" means the Secretary of Agriculture.
 - 1 2. No person shall operate or conduct a disposal plant without a
 - 2 license from the department. The department shall, by rule and
 - 3 regulation adopted in accordance with the "Administrative Pro-
- 4 cedure Act," P. L. 1968, c. 410 (C. 52:14B-1 et seq.), set fees for

- 5 licenses and set reasonable inspection and sanitation standards for
- 6 operators, buildings, containers and vehicles. Fees for licensing
- 7 shall cover clerical, printing and inspection costs of the department.
- 1 3. A licensee shall, upon the presentation of official credentials
- 2 by any department employee or other duly authorized representa-
- 3 tive of the Secretary of Agriculture, during ordinary business
- 4 hours, permit the representative to enter his place of business and
- 5 examine the records required to be kept under section 4 of this act
- 6 and the facilities and inventory pertaining to the business of the
- 7 licensee, and to take reasonable samples of the inventory. Any
- 8 necessary facilities, other than reproduction equipment, for the
- 9 examination and copying of records and for the examination and
- 10 sampling of inventory shall be afforded to the department employee
- 11 or other authorized representative of the secretary.
 - 4. Each licensee shall keep at his place of business a record of
- 2 each place at which he obtains carcasses of domestic animals con-
- 3 taining location, name and address of owner, date picked up and the
- 4 sequence in which carcasses are picked up from each place on each
- 5 date.

- 5. A licensee may haul and transport the carcasses of animals
- 2 that have died from disease in a covered vehicle, bed or tank which
- 3 is watertight and is so constructed that no drippings or seepings
- 4 from the carcasses can escape from the vehicle, bed or tank. Such
- wehicle shall not be driven into the yard, or upon the premises of
- 6 any person, unless the driver first obtains the permission of the
- 7 person.
- 6. a. The department shall annually adopt a penalty schedule for
- specific violations of the provisions of this act or regulations
- 3 adopted pursuant to this act. Penalties shall be set between a
- 4 minimum of \$100.00 to a maximum of \$3,000.00 per violation.
- 5 b. Penalties shall be collected in a summary proceeding pursuant

This bill would grant the Department of Agriculture the authority to inspect plants engaged in dead animal disposal. These plants either convert the animals into animal feed, fertilizer or render them into fats, oils, hides, etc. This bill would require disposal plant operators to be licensed and to keep records of the origin of the dead animals. The records could then be used to trace an animal which died of a disease back to the herd of origin, thereby minimizing the potential spread of the disease. Fees for licensing would cover the department's clerical, printing and inspection costs.

A-3065, sponsored by Assemblywoman Marie S. Muhler, M_{A4} // R-Monmouth, which establishes an educational information and resource center in South Jersey and authorizes it to take over all the assets of the Educational Improvement Center in the southern region of the State. The bill also terminates the three Educational Improvement Centers in the central northwest and northern regions of the State.

S-524, sponsored by State Senator John H. Dorsey, R-Morris, which extends the tort immunity granted public employees for injury caused by failure to perform adequate health examinations, to private plusicians while performing professional services for a public entity as a volunteer without compensation. The immunity applies to examinations for public health purposes (tuberculosis, eye, hearing etc). It does not apply to examinations for the purpose of treatment such as are ordinarily made in hospitals or doctors offices.

A-1764, sponsored by Assemblyman Raymond Lesniak, D-Union, which requires that all liens imposed to recover expenditures from the State Spill Compensation Fund be filed with the clerk of the Superior Sourt and the clerk of Deeds and Mortgages in the county where the affected property is located.

S-868, sponsored by State Senator Raymond J. Zane, D-Gloucester, which grants the Department of Agriculture the authority to license and inspect plants Which dispose of dead animals by converting them to animal feed or fertilizer or rendering them into fats, oils or hides. The bill would require the plant operator to keep records of the origin of the dead animals, thus allowing investigators to trace back sources of disease to the herd of origin.

A-2091, sponsored by Assemblyman Anthony M. Villane, P-Monmouth, which transfers \$300,000 from State aid funds previously appropriated for the dredging of inland waterways to provide additional functing for Marine Police operations.
