INTRODUCED FEBRUARY 28, 1983

AN ACT to amend "The State Facilities Education Act of 1979,"  
approved September 25, 1979 (P. L. 1979, c. 207).

1 BE IT ENACTED by the Senate and General Assembly of the State  
2 of New Jersey:

1 1. Section 8 of P. L. 1979, c. 207 (C. 18A:7B-4) is amended  
2 to read as follows:

3 8. Funds received pursuant to this act by the Department of  
4 Human Services or by the Department of Corrections shall be used  
5 only for the salaries of teachers, educational administrators at the  
6 program level, child study team personnel, **[and]** *clerical staff*  
7 *assigned to child study teams or to educational day programs*, para-  
8 professionals assigned to educational programs in State facilities,  
9 *and for diagnostic **\*[and related services personnel]\*** *\*services**

10 *required as part of the child study team evaluations and related*  
11 *educational services personnel whose function requires an educa-*  
12 *tional certificate issued by the State Department of Education\**,  
13 and for the costs of educational materials **[and]**, supplies *and*  
14 *equipment* for these programs. No such funds shall be used for  
15 the renovation or construction of capital facilities, for the mainte-  
16 nance and operation of educational facilities, or for custodial,  
17 habilitation or other noneducational costs.

18 There are hereby authorized to be appropriated to the Depart-  
19 ments of Human Services and Corrections such funds as may be  
20 necessary to provide for adult, post-secondary and college pro-  
21 grams.

1 2. This act shall take effect immediately.

This bill allows funds appropriated to the Department of Education for the education of children in State facilities (P. L. 1979, c. 207) to be used to pay the cost of educational equipment, diagnostic personnel and clerical staff assigned to child study teams for children in facilities operated by the Department of Human Services and Corrections.

The committee amendments clarify the intent of the bill.

Governor Thomas H. Kean has signed the following bills:

A-3230, sponsored by Assemblyman Joseph A. Palia, R-Monmouth, which allows the cost of educational equipment and salaries for certain clerical and diagnostic staff to be funded under the State Facilities Education Act. That act provides money to the Departments of Human Services and Corrections to establish educational programs for pupils who are eligible for day training using State facilities. This bill corrects an oversight which omitted vital clerical and diagnostic positions from funding eligibility.

AJR-29, sponsored by Assemblyman Walter J. Kavanaugh, R-Somerset, which designates State Police Troop B Headquarters building in Totowa as the "Trooper Philip Lamonaco State Police Headquarters Building."

S-484, sponsored by State Senator Wayne Dumont, Jr., R-Warren, which permits tax exempt institutions to lease portions of their properties during times of the year that they are not in session without losing their tax exempt status.

S-3026, sponsored by State Senator Frank E. Rodgers, D-Hudson, which permits a county or municipality to pay the entire cost of health insurance premiums for retirees who are at least 62 years old, have 15 years or more of service and retire based upon a medical illness or disability.
