An Act concerning proof of ownership of motor vehicles in criminal proceedings.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. In any criminal proceeding in which ownership, possession,
- 2 or use of a motor vehicle is an issue, a certified copy of the certifi-
- 3 cate of ownership on file with the Director of the Division of Motor
- 4 Vehicles or with the official custodian of documents certifying
- 5 ownership of a motor vehicle in another state shall be admissible
- 6 in evidence as prima facie proof of ownership of the motor
- 7 vehicle*.* *Land that possession or use of the motor vehicle by a
- 8 person not named in the certificate was without the consent or
- 9 authority of the owner.
- 10 Upon the introduction of evidence that the lawful owner of the
- 11 motor vehicle is one not named in the certificate of ownership or
- 12 that use or possession was with the consent or authority of the
- 13 owner, a continuance shall be granted upon the request of any
- 14 party for such time as the court determines is reasonably required
- 15 to enable the owner of the vehicle to be brought into court to
- 16 testify.]*

DATED: AUGUST 12, 1982

The purpose of this bill is to permit certified copies of certificates of ownership of motor vehicles to be introduced in evidence in criminal proceedings in which ownership, possession, or use of a motor vehicle is an issue. The certified copies would be considered prima facie proof of ownership of the motor vehicle and prima facie proof that possession or use of the motor vehicle by a person not named in the certificate occurred without the consent of the owner.

If evidence were introduced indicating that the lawful owner was not the person named in the certificate or that use or possession of the vehicle occurred with the consent of the owner, a continuance would be granted upon the request of any party to enable the owner of the vehicle to appear in court to testify.

The bill is intended to prevent the dismissal of cases in which an owner does not appear when necessary. Often, the defendant repeatedly postpones the case until the owner fails to show up.
