### STATEMENT

The purpose of this bill is to ban so-called paramilitary training camps operated by the Ku Klux Klan or other extremist groups. To accomplish this, the bill makes the teaching of the use of a firearm, explosive device or any technique capable of causing injury with the knowledge that such firearm, device or technique will be employed in connection with civil disorder, a crime of the third degree. The bill also classifies as a crime of the third degree assembling to learn the use of a firearm, explosive device or technique capable of causing injury with the intent to employ such firearm, device or technique in civil disorder. Crimes of the third degree are punishable by between 3 and 5 years imprisonment (presumptive sentence 4 years) and/or a fine of up to \$7,500.00.

## STATE OF NEW JERSEY

DATED: SEPTEMBER 21, 1982

This bill, as amended, would make it a crime of the third degree for a person to provide instruction in the use of a firearm, explosive device, or any technique capable of causing injury or death, if the person intended it to be used in connection with an illegal activity.

The bill would also make it a crime of the third degree for a person to assemble with others for the purpose of receiving instruction in the use of a firearm, explosive device, or any technique capable of causing injury or death if the person intended to employ it in an illegal activity.

A crime of the third degree is punishable by imprisonment for 3 to 5 years, with a presumptive term of 4 years, and/or a fine of up to \$7,500.00.

The committee, in amending this bill by eliminating the civil disorder definition and adding the illegal activity requirement, intends to prohibit any type of training that would result in the commission of a crime and does not intend to infringe on the rights of law enforcement officers to bear arms.

# STATE OF NEW JERSEY

DATED: MAY 24, 1982

The purpose of this bill, as amended, is to prohibit so-called paramilitary training camps operated by the Ku Klux Klan or other extremist groups from establishing themselves in New Jersey.

The bill would make it a crime of the third degree for a person to provide instruction in the use of a firearm, explosive device, or any technique capable of causing injury or death, if the person intended it to be used in connection with a civil disorder.

The bill would also make it a crime of the third degree for a person to assemble with others for the purpose of receiving instruction in the use of a firearm, explosive device, or any technique capable of causing injury or death if the person intended to employ it in a civil disorder.

A crime of the third degree is punishable by imprisonment for 3 to 5 years, with a presumptive term of 4 years, and/or a fine of up to \$7,500.00.

The amendments are technical in nature. The purpose of the amendments is to conform the bill with definitions that appear in chapter 39 of Title 2C, the Criminal Code.

S-971, sponsored by State Senator Matthew Feldman, D-Bergen, which bars paramilitary training camps by making it illegal to teach the use of firearms, explosives and other harm-causing techniques with the knowledge that the techniques will be used in connection with an illegal activity.

S-449, sponsored by State Senator Richard J. Codey, D-Essex, which exempts ambulances owned by non-profit organizations from motor vehicle registration fees.

SJR-3019, sponsored by State Senator Daniel J. Dalton, D-Camden, which directs the Governor to exercise an existing statute which requires automatic retaliation against taxes imposed by other states on New Jersey residents. The tax in this case is a Pennsylvania motor vehicles tax of \$36 per axle on trucks above 26,000 pounds. That law, effective April 1, 1983, falls heavily on truck owners who are not residents of Pennsylvania. The retaliation would be in the form of a similar tax imposed on vehicles registered in Pennsylvania.
