AN ACT to amend the title of "An act establishing the New Jersey Neuropsychiatric Institute within the Department of Institutions and Agencies, providing for the administration thereof, supplementing Title 30 of the Revised Statutes, and repealing sections 30:4-166, 30:4-167, 30:4-168 and 30:4-169 of the Revised Statutes," approved April 28, 1953 (P. L. 1953, c. 122), so that the same shall read "An act establishing the North Princeton Developmental Center within the Department of Human Services, providing for the administration thereof, supplementing Title 30 of the Revised Statutes, and repealing sections 30:4-166, 30:4-167, 30:4-168 and 30:4-169 of the Revised Statutes," \***[and]**\* to amend and supplement the body of said act \*and amending R. S. 30:1-7\*.

1 BE IT ENACTED *by the Senate and General Assembly of the State*  
2 *of New Jersey:*

**STATEMENT**

The purpose of this bill is to change the name of the New Jersey  
Neuropsychiatric Institute to the North Princeton Developmental  
Center.

The facility currently provides services for mentally retarded  
males and females and administers a Statewide neurological con-  
sultation service. Administration of the facility was transferred  
from the Division of Mental Health to the Division of Mental Re-  
tardation several years ago and the change in name reflects the  
new resident population at the facility.

The purpose of this bill is to change the name of the New Jersey Neuropsychiatric Institute to the North Princeton Developmental Center.

The change in name reflects the fact that the Division of Mental Retardation in the Department of Human Services now administers the facility, which currently provides services for mentally retarded males and females and operates a Statewide neurological consultation service.

This bill changes the names of the seven State schools for the mentally retarded to "developmental centers."

Originally, the bill only changed the name of the New Jersey Neuro-psychiatric Institute to the North Princeton Developmental Center because that facility is now administered by the Division of Mental Retardation and no longer provides psychiatric services. However, the bill was amended in the General Assembly to change the names of the other six facilities for the mentally retarded to reflect their current focus on developmental care.

Governor Thomas H. Kean has signed the following bills:

AJR-24, sponsored by Assemblyman Robert E. Littell, R-Sussex, which directs the Division of Parks and Forestry to prepare and submit to the Legislature a master plan for the management of the State's forest lands. The plan, due by March 1, 1984, is to include a detailed summary of the level and efficiency of forest management in the State, a plan for upgrading current management practices to ensure that New Jersey's timber resources are used to the fullest extent and an estimate of the costs of such an upgrading and the revenues it can be expected to yield. The resolution was the subject of a conditional veto.

A-1612, sponsored by Assemblyman Walter J. Kavanaugh, R-Somerset, which changes the names of various State schools to reflect their new status as program facilities as compared to their former function as strictly custodial care facilities.

A-3239, (merged), sponsored by Assemblyman Martin A. Herman, D-Salem, and State Senator John F. Russo, D-Ocean, which extends the authorization for the New Jersey Wiretapping and Electronic Surveillance Control Act until July 1, 1988.

A-1244, sponsored by Assemblyman Robert P. Hollenbeck, D-Bergen, which authorizes the Department of Environmental Protection to license operators of water supply and wastewater treatment plants and systems. The bill was the subject of a conditional veto.

S-971, sponsored by State Senator Matthew Feldman, D-Bergen, which bars paramilitary training camps by making it illegal to teach the use of firearms, explosives and other harm-causing techniques with the knowledge that the techniques will be used in connection with an illegal activity.

S-449, sponsored by State Senator Richard J. Codey, D-Essex, which exempts ambulances owned by non-profit organizations from motor vehicle registration fees.

SJR-3019, sponsored by State Senator Daniel J. Dalton, D-Camden, which directs the Governor to exercise an existing statute which requires automatic retaliation against taxes imposed by other states on New Jersey residents. The tax in this case is a Pennsylvania motor vehicles tax of \$36 per axle on trucks above 26,000 pounds. That law, effective April 1, 1983, falls heavily on truck owners who are not residents of Pennsylvania. The retaliation would be in the form of a similar tax imposed on vehicles registered in Pennsylvania.
