An Act authorizing and validating certain transfers of title and interest in lands and buildings to war memorial commissions and supplementing Title 40 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. A municipality or county, or both, may transfer to the commis-
- 2 sion its or their title or interest in any lands conveyed to it or
- 3 them under the provisions of P. L. 1924, c. 189 or P. L. 1925, c. 18,
- 4 saved from repeal by R. S. 52:20-24, or under the provisions of
- 5 P. L. 1962, c. 220 (C. 52:31-1.1 et seq.), which lands were conveyed
- 6 for the purpose of erecting thereon a memorial building or build-
- 7 ings, and may transfer to the commission its or their title or
- -8 interest in any building or buildings erected on those lands.
 - 2. Every conveyance of land referred to in section 1 of this act
- 2 heretofore executed and delivered by a municipality or county, or
- 3 both, to a commission established under R. S. 40:10-3, is hereby
- 4 validated and confirmed.
- 1 3. This act shall take effect immediately.

Assembly Bill No. 3265 authorizes a county, municipality, or county and municipality jointly, to transfer to a war memorial commission the title to, or any interest in, land originally conveyed to the county, municipality or both by the State for the purpose of erecting a war memorial. The bill also authorizes the transfer of title to or interest in any buildings erected on such land.

In addition, the bill validates any previous land transfer of this nature.

Assembly Bill No. 3265 clarifies the statutory authority of municipalities and counties to transfer to war memorial commissions the title to lands or buildings previously conveyed to the municipality or county by the State for the purpose of erecting a memorial building or buildings. The bill also validates transfers to a commission made prior to the effective date of this act.

Governor Thomas H. Kean has signed the following bills:

A-1515, sponsored by Assemblywoman Catherine A. Costa, D-Burlington, which consolidates 56 separate existing laws into a single act governing the operation of State Parks and Forests.

A-3396, sponsored by Assemblyman Willie Brown, D-Essex, which amends the New Jersey Local Development Financing Fund Act to include a county development corporation as a project sponsored with the approval of the county government.

A-3265, sponsored by Assemblyman John S. Watson, D-Mercer; which validates certain transfer of title in lands and buildings to War Memorial Commissions. The bill will permit the State to convey title to the land occupied by the Trenton War Memorial Building to the Trenton and Mercer County War Memorial Commission.

A-1301, sponsored by Assemblyman Thomas H. Paterniti, D-Middlesex, which provides for salvage certificates of title for stolen and destroyed motor vehicles. The bill is intended to prevent the use of regular certificates of title from being used to register stolen vehicles after the original vehicle habeen stolen or wrecked. It requires the owner of a stolen or wrecked vehicle to turn in the regular certificate in exchange for a "salvage certificate. Should a stolen vehicle be recovered, the owner can obtain new certificate of title by turning in the salvage certificate.

A-201, sponsored by Assemblyman Edward K. Gill, R-Union, permits county clerks to destroy county court records if the recormore than 25 years old and form no part of an enforceable judgment.
