This bill would create a five-member, appointed board for the Sussex county vocational school, and would require its budget to be approved by the county board of school estimates rather than being approved by the voters.

Assembly Bill No. 3436 provides that the board of education members of county vocational schools in Sussex county shall be appointed rather than elected. Also, the bill would provide that Sussex county vocational school budgets would be approved by the county board of school estimate rather than being approved by the voters. Currently, vocational school board members in Sussex and Warren counties are elected, and the budgets are approved, by the voters at elections held in April. In every other county in which there is a county vocational school, the board members are appointed.

The amendment, at the request of the sponsor, changes the date by which the first board members shall be appointed from December 1 to December 31, 1983.
