#### INTRODUCED OCTOBER 18, 1982

An Acr concerning county and municipal support of first aid and emergency or volunteer ambulance or rescue squad associations, and amending R. S. 40:5-2.

- 1 Be it enacted by the Senate and General Assembly of the State

In 1978, this section of law was amended to require that the chief financial officer of the county or municipality perform an audit of any first aid, emergency or volunteer ambulance or rescue squad which received a voluntary contribution from the local governmental unit.

The amendment placed undue responsibility on the local financial officer and has forced him to assume certain financial oversight functions with regards to the recipient voluntary organizations.

The purpose of this amendatory bill is to free the chief financial officer from such oversight responsibilities while still assuring that the local unit's voluntary contribution is being utilized in an appropriate manner.

Under the provisions of this bill, the chief financial officer would receive a copy of a recipient association's annual audit and file it with the clerk of the county or municipality.

# STATE OF NEW JERSEY

**DATED: JUNE 23, 1983** 

Assembly Bill No. 2021 would eliminate the current statutory requirement that the chief financial officer of the county or municipality perform an audit of any first aid, emergency or volunteer ambulance or rescue squad which receive a voluntary contribution from the local governmental unit. Under the provisions of the bill, the chief financial officer would receive a copy of a recipient association's annual audit and file it with the clerk of the local unit which made the contribution.

Under current law, counties and municipalities are permitted to contribute up to \$25,000.00 a year to any duly incorporated first aid, emergency or volunteer ambulance or rescue squad which serves the needs and citizens of the local unit. If the association is able to demonstrate "extraordinary need," the local unit may contribute an additional \$25,000.00.

Whenever a local unit makes such an additional contribution, the law requires that the chief financial officer of the unit perform an annual audit of the association. This bill eliminates that requirement, which has placed undue responsibility on the local financial officer, and has forced him to assume certain financial oversight functions with respect to the recipient associations.

The Senate committee amendments clarify the audit requirements, by requiring that the audit be performed by a certified public accountant or registered municipal accountant, and be for the previous fiscal year's financial records.
