### Provisions:

Assembly No. 935 represents a technical amendment to the statutes governing the annual organization of school boards.

#### BACKGROUND:

Chapter 140 of the laws of 1980 moved the annual organizational meeting of all Type II boards of education from the first Monday following May 15th to any day of the first week following the annual school election. Assembly No. 935 amends the chapter governing regional boards of education to make it conform with the dates set forth in the chapter governing the organization of boards in all Type II districts.

Governor Thomas H. Kean today signed legislation requiring newly-elected school board members in regional school districts to hold their initial organizational meeting within one week following their election.

The bill,  $\Lambda$ -935, sponsored by Assemblyman Richard Van Wagner (D-Monmouth), amends the current law which required the first organizational meeting to take place during the first week after May 15.

A law enacted last year changed the starting dates of regional school board members terms of office from May 15 to the first week following the election---normally the first Tuesday in April.

The bill signed today by the Governor is intended to conform the meeting requirement with the new term dates and prevent what would have otherwise been a six week delay between the beginning of a term and the first meeting of the school board.
