# STATE OF NEW JERSEY

**INTRODUCED SEPTEMBER 30, 1982** 

By Assemblymen LESNIAK, DEVERIN, PATERO and BOCCHINI

An Act concerning child labor and supplementing P. L. 1940, c. 153 (C. 34:2-21.1 et seq.).

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 17 of P. L. 1940, c. 153 (C. 34:2-21.17) shall not apply 2 to minors under the age of 18 years who participate or work in any 3 junior achievement program. As used in this act "junior achieve-4 ment program" means any program under which minors under the 5 age of 18 engage in business enterprises or activities pursuant to an 6 economic education program conducted under the guidance of 7 adult sponsors from private business and industry.

1 2. This act shall take effect immediately.

Governor Thomas H. Kean has signed the following bills:

<u>A-1986</u>, sponsored by Assemblyman Raymond Lesniak, D-Union, which exempts minors who are participating in Junior Achievement programs from the employment restrictions relating to specific occupations, hazardous conditions or the use of certain machinery. Junior Achievement is a private economic education program involving some 3,500 New Jersey students each year. The exemptions provided for in this bill will allow participants, supervised by counseilors from business and industry, to participate in registered apprentiveship programs and other cooperative education programs.

A-663, sponsored by Assemblywoman Barbara F. Kalik, D-Burlington, which increases the type of debt obligations which can be used as collateral or security by institutions now holding government funds on deposit.

A-535, sponsored by Assemblyman John O. Bennett, which permits local harbor and waterfront commissions to act of expenditures leases and property transfers up to 52,500 without governing body approval. The current level is \$500.
