An Act concerning alcoholic beverages\*\*[, amending R. S. 33:1-28]\* and supplementing chapter 1 of Title 33, of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State

# STATE OF NEW JERSEY

DATED: SEPTEMBER 30, 1982

The Assembly Commerce and Industry Committee favorably reports this bill, as amended, to allow a retail consumer who purchases wine in person and on the premises from a plenary winery with retail privileges or from a farm winery to authorize the winery to ship the wine to a destination within the State by an approved parcel delivery service.

There are currently seven plenary wineries with retail privileges and two farm wineries licensed in New Jersey.

The parcel delivery service used by such a winery must be approved by the Director of the Division of Alcoholic Beverage Control (ABC). However, the parcel delivery service will not be required to obtain a transportation license for alcoholic beverages (R. S. 33:1-13) or to have a transit insignia on its trucks (R. S. 33:1-28) which, in the past, have cost \$500.00 and \$25.00 per truck, respectively. A winery which is covered by the provisions of this bill and which wants to have this delivery service available to its customers must file an application therefor and pay an annual fee of \$150.00 to the director. Also, the bill provides that the truck driver delivering the wine must seek to determine that the party signing the delivery receipt is of legal age to consume alcoholic beverages.

The original section 2 of the bill required the winery to maintain a copy of each invoice for one year; the new section 1 requires the winery to maintain a copy of each invoice for three years. Although retail licensee who deliver their own alcoholic beverages must maintain their invoices for a period of one year (N. J. A. C. 13:2–20.2), a licensed transporter of alcoholic beverages must maintain invoices for a period of three years (N. J. A. C. 13:2–39.2(b)).

Due to the expense of licensing and insignia fees charged to carriers, few, if any, have opted to provide delivery service to New Jersey's wineries. The results of a survey conducted by a New Jersey winery of wineries in other states suggested that the regular use of a shipping service such as the United Parcel Service allowed them to develop new business, increase sales and promote customer relations. It is hoped that this bill will begin to restore New Jersey's wineries to a competitive position with out-of-state domestic wine producers.

Governor Thomas H. Kean today signed the following bills:

<u>S-1582</u>, sponsored by Senator H. James Saxton, R-Burlington, which provides that a governing body fixing a budget for a fire district, include in the budget enough money to cover debt service. Currently, if a fire district's budget is rejected by voters, the governing body must fix an annual budget for the district, but is prevented from exceeding the previous year's amount in any given category. This creates problems in cases where voters authorize a debt, then fail to approve a budget to pay for it. This bill allows the governing body to appropriate enough money in a rejected budget to meet debt service requirements.

A-1111, sponsored by Assemblywoman Leanna Brown, R-Morris, which makes permanent amendments in the laws applying to the size of no smoking signs in some public buildings. The original law required signs with letters two inches high, which made the signs too big to be practical. The amendment allows for one inch high letters or the international "No Smoking" symbol.

A-1885, sponsored by Assemblywoman Barbara F. Kalik, which authorizes New Jersey wineries to ship wine to addresses within the State by retail delivery services which are otherwise not licensed to transport alcoholic beverages. The law previously required that retail delivery services pay a \$500 license fee to carry alcoholic beverages. That requirement is now removed for New Jersey domestic wine delivered within the State.

<u>S-611</u>, sponsored by Senator S. Thomas Gagliano, R-Monmouth, which creates an exemption from the firearm purchase permit laws for the purchase of safety and emergency flare devices for boats and aircraft.
