## STATE OF NEW JERSEY

### ADOPTED JANUARY 26, 1981

An Acr concerning the appointment of a chief of police by the Palisades Interstate Park Commission and supplementing Title 32 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State

An Act concerning the chief of police of the Palisades Interstate Park Commission and amending R. S. 11:4-4.

#### STATEMENT

The purpose of this amendatory bill is to make the chief of police of the Palisades Interstate Park Commission a member of the unclassified service. All other changes are purely technical and serve only to make the law consistent with the current structure of State and local governments.

This bill, as originally drafted, amended R. S. 11:4-4 to add the chief of police of the Palisades Interstate Park Commission to the list of those State employees who are in the unclassified service of the Civil Service. The bill is now in the form of a committee substitute supplementing Title 32 (Interstate and Port Authorities and Commissions).

Pursuant to the law governing the Palisades Interstate Park Commission (R. S. 32:14-1 et seq.), all employees are to be subject to the civil service statutes "of the party states." The commission is a multi-jurisdictional, interstate agency. The commission police force is split into two jurisdictions — New York and New Jersey — with each force having its own chief of police. It is the understanding of staff that there is no present plan by New York to place the police chief of the New York force in the unclassified service. Mr. Nash Castro, general manager for the commission, points out that the New York "side" of the commission is under the jurisdiction of the New York State Office of Parks and Recreation, which controls several police forces throughout the state. The commission, therefore, had a long eligibility list from which to select the police chief for the New York force. The eligibility list for the New Jersey police chief is only seven men.

It is the position of the commission that the placement of the job title of police chief in the unclassified service will give the commission "the widest latitude from which to make the selection."

The total New Jersey police force for the commission numbers 30, although 36 positions are authorized. Of that force, two are lieutenants, six are sergeants and the remainder are patrolmen. The two lieutenants and five of the sergeants are eligible to take the examination for promotion to chief.

The Civil Service Commission is empowered by law to place positions on the unclassified list. The Palisades Interstate Park Commission requested this action; however, their appeal has been denied by the Civil Service Commission.

#### SENATE COMMITTEE SUBSTITUTE

The sponsor has agreed to a committee substitute for the bill. As originally drafted, Senate Bill No. 1345 amended R. S. 11:4-4 to provide that a single individual with a specific title be in the unclassified service of the Civil Service. The statute amended establishes general categories of job titles which are in the unclassified service. The bill would have placed a particular individual among these categories.

The committee substitute supplements Title 32 to give the authority to the Palisades Interstate Park Commission to appoint a chief of police, who shall be in the unclassified service of Civil Service. The police chief so appointed would be required to have served as a superior police officer and have at least 5 years administrative and supervisory police experience. There is a precedent for this substitute in P. L. 1979, c. 163 (C. 40:69A-60.7), which gives this authority to the governing body of certain cities of the first class.

S-1333, sponsored by Senator Wynona M. Lipman (D-Essex), which permits Essex County, as a first class county with a 1970 population exceeding 900,000 to appoint certain temporary employees to permanent positions without examination. The bill favors employees whose salaries are now paid by federal funds under the Federal Housing and Community Development Act, and who have held their positions for 18 months preceding the effective date of the act. The employees must meet minimum job qualifications and have a satisfactory job performance rating. The bill will affect four or five persons.

S-1345, sponsored by Senator Matthew Feldman (D-Bergen), which places the position of police chief of the Palisades Interstate Park Commission. New Jersey force, in the unclassified service of the Civil Service. The chief must have at least five years of administrative and supervisory police experience.

<u>S-1599</u>, sponsored by Senator Wynona Lipman (D-Essex), which extends the life of the Commission on Sex Discrimination in the statutes to January 10, 1984. The commission issued its first report, "Sex Discriminati in the Employment Statutes," in October 1979. The legislation implementing the employment recommendations was signed into law in August, 1980. Currently the commission is studying the marriage and family statutes.

A-1166, sponsored by Assemblyman C. Louis Bassano (R-Union), which regulates bulk purchases of precious metals, which are defined as gold, silver, platinum and their alloys.

According to the bill, the buyer must identify himself to the seller, weigh the precious metals in the seller's presence, test the metal, and indicate the price being paid per standard measure of weight and fineness. Certain record keeping of purchases is mandated, and the bulk buyer must obtain a bond in an amount and form prescribed by the Office of Weights and Measures.
