# STATE OF NEW JERSEY

PRE-FILED FOR INTRODUCTION IN THE 1980 SESSION

An Act concerning special motor vehicle registration plates for former prisoners of war, and supplementing chapter 3 of Title 39 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State

- 1. Upon the application of any person who served in the armed
- 2 forces of the United States and who was held as a prisoner of war
- 3 by an enemy of the United States during any armed conflict, as
- 4 certified by the Division of Veterans Programs and Special Ser-

- 6 Division of Motor Vehicles shall issue for the motor vehicle owned
- 7 by such person special plates\*\*\*[, at a fee to be prescribed by the

- 9 tion number and other markings or identification otherwise pre-
- 10 scribed by law. \*The fee for the plates shall be \$15.00, in addition
