The purpose of this bill is to collect an additional \$5.00 fee for the issuance of a marriage license for the purpose of establishing a trust fund within the Department of Human Services. This fund shall be used for the establishment and maintenance of shelters for victims of domestic violence, or for providing grants-in-aid to such shelters established by local governments or private non-profit organizations.

The committee amended the bill to require that the licensing officer forward the fees on a quarterly basis to the department.

Acting-Governor Joseph P. Merlino today signed into law <u>A-618</u>, requiring applicants for marriage licenses to pay a \$5.00 fee in addition to the current \$3.00 charge. The bill also provides for the establishment and maintenance of shelters for victims of domestic violence, to be financed by revenues from the \$5.00 license charge.

The bill will raise an estimated \$300,000 each year. Funds for shelters will be provided in grants-in-aid form.

The bill was sponsored by Assemblyman John Paul Doyle (D-Ocean).
