An Act to amend "An act concerning relief of certain persons who served in the active military or naval forces of the United States, and supplementing Title 38 of the Revised Statutes," approved June 11, 1947 (P. L. 1947, c. 263), as said title was amended by P. L. 1948, c. 138.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. Section 1 of P. L. 1947, c. 263 (C. 38:18A-1) is amended
- 2 to read as follows:
- 3 1. As used in this act, the word "veteran" means and includes
- 4 any officer, soldier, sailor, marine, airman, nurse, or any other
- 5 person, male or female, regularly enlisted or inducted, who was or
- shall have been a part of the active military or naval forces of
- 7 the United States, and who took part or shall have taken part
- 8 in any war in which the United States was engaged, or who took
- 9 part or shall have taken part in the wars with the governments
- 10 of Japan, Germany and Italy, or any of them, or who served or
- 11 shall have served in the active military or naval service of the
- 12 United States in time of emergency as herein defined, and who
- 13 was a resident of this State at the time he was or shall be
- 14 commissioned, enlisted, inducted, appointed or mustered into the
- 15 active military or naval service of the United States, and who has
- 16 been or shall have been given a discharge or release therefrom
- 17 under conditions other than dishonorable and continues to be a
- 18 resident of this State.
- 19 As used in this act the term "in time of emergency" shall mean
- 20 (a) the Korean conflict and include any time after June 23, 1950,
- 21 and prior to July 27, 1953 [the termination, suspension or revoca-
- 22 tion of the proclamation of the existence of a national emergency

- 2. Section 2 of P. L. 1947, c. 263 (C. 38:18A-2) is amended to

- 5 has permanent paralysis of both legs and lower parts of the body,
- 6 or who is suffering from osteochondritis and has permanent loss
- 7 of the use of both legs, or who is suffering from hemiplegia and
- 8 has permanent paralysis of one leg and one arm or either side of
- 9 the body, resulting from injury to the spinal cord, skeletal struc-
- 10 ture, or brain or who has suffered amputation of both hands, both
- 11 feet or one hand and one foot, or who has lost the use of both
- 12 feet or both legs, due to multiple sclerosis, sustained through enemy
- 13 action, or accident, or resulting from disease contracted while in
- 14 such active military or naval service, shall be paid for the term of
- 15 his life the sum of [\$500.00] \$750.00 annually in monthly payments.
- 16 Such payments shall be due and payable from the date of his dis-
- 17 charge or release if application therefor shall be made within one
- 18 year from the date of such discharge or release. If the application
- 19 shall be made after 1 year from the date of his discharge or re-
- 20 lease, such payment shall be due and payable from the date of
- 21 such application. Accrued payments to the date of certification shall

- Nothing in this act shall be intended to include paraplegia or

- 3. Section 3 of P. L. 1947, c. 263 (C. 38:18A-3) is amended to
- 2 read as follows:
- 3. Evidence of the service and disability mentioned in this act
- 4 shall be furnished to the Division of Veteran's Services of the
- 5 Department of [Conservation and Economic Development] Human
- 6 Services, which shall examine the same and upon being satisfied
- 7 that the service was performed and the veteran has been rendered

- 8 permanently paralyzed or has permanently lost the use of both legs,
- 9 or has suffered amputation, as defined in section 2 of this act, shall
- 10 so certify to the Director of the Division of Budget and Accounting
- 11 in the Department of the Treasury, who shall, upon receipt thereof,
- 12 draw his warrant on the State Treasurer in favor of the applicant

Senate Bill No. 741 amends that section of law that provides an annual payment to veterans with service connected paraplegia, osteochondritis, hemiplegia, multiple sclerosis or double amputation.

The bill increases the amount of the payment from \$500.00 to \$750.00. It secondly authorizes the payment to be made to qualified Vietnam era veterans.

The program cost has been \$170,000.00 for the last several years, providing payments to 340 veterans. Increasing the payments by \$250.00 would cost an additional \$85,000.00. It is estimated by the Division of Veteran Services that approximately 20 to 30 Vietnam era veterans would become eligible at a cost of between \$15,000.00 and \$22,500.00. The total cost of the bill, therefore, would be approximately \$107,000.00.

The committee amended the bill to make the provisions of section 3 otherwise consistent with the current version of law.

This bill increases the benefits payable to paraplegic or hemiplegic veterans, pursuant to the provisions of Title 38, from \$500.00 per year to \$750.00 per year. The bill also amends the definition of "in time of emergency" to conform the dates of the Korean conflict with the dates for that conflict as given in other statutes, and to include the Vietnam conflict within the scope of the definition.

In FY-81, the recommended appropriation for the benefits presently payable under the law is \$170,000.00. The number of veterans presently eligible for benefits is 340. The Division of Pensions estimates that between 20 and 30 Vietnam-era veterans will become eligible if this bill is passed. The division estimates the total cost of the legislation would be approximately \$104,000.00.
