An Act to amend "An act fixing the annual compensation of members of the Senate and General Assembly and providing for the payment thereof and for the payment of an additional allowance to the President of the Senate and the Speaker of the General Assembly," approved April 9, 1948 (P. L. 1948, c. 16).

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. Section 1 of P. L. 1948, c. 16 (C. 52:10A-1) is amended to
- 2 read as follows:
- 3 1. Members of the Senate and General Assembly shall receive
- 4 annually, during the term for which they shall have been elected
- 5 and while they shall hold their office, compensation in the sum of
- 5 [\$10,000.00 each, until the beginning of the legislative year following
- 7 the next general election for members of the General Assembly
- 8 and thereafter and beginning with said legislative year they shall
- 9 receive annually during the term for which they shall have been

Governor Brendan Byrne late Tast night signed a package of five bills which together aise the salaries of the Governor, State legislators; the Governor's cabinet members and members of the judiciary, and turn the Judicial Retirement System into a partial ontributory system.

The five bills were tied together by the Legislature, requiring the enactment fall for any one to become effective.

A-3799 increases the Governor's salary from \$65,000 to \$85,000 per year;
A-3800 raises each State legislator's salary from \$18,000 to \$25,000 per ear, beginning in 1984;

A-3802 increases Cabinet salaries from \$56,000 to \$70,000 per year, with the xception of the Defense Department Chief of Staff, whose salary is raised from \$53,000 to \$67,500 per year;

A-3801 raises the salary of the Supreme Court's Chief Justice from \$65,000 to 80,000 per year, the Court's Associate Justices from \$63,000 to \$78,000, Appellate livision judges from \$60,000 to \$75,000, Assignment judges \$58,000 to \$73,000, and 11 other court judges from \$55,000 to \$70,000 per year; and

A-3798 requires that three-percent of the judicial salary increase granted in 3801 be contributed to the Judicial Retirement System each year. Judges were previously ot required to contribute to a State pension plan.

With the exception of of A-3798, which was sponsored by Assemblyman James R. urley (R-Cape May), all the bills were sponsored by Assemblyman Dean A. Gallo (R-brris).

All of the bills take effect January 19, 1982, although legislative pay raises ill not become effective until 1984.
