INTRODUCED JANUARY 13, 1981

By Senator CAUFIELD

Referred to Committee on Institutions, Health and Welfare

An Acr establishing a commodities and services council for blind and other severely handicapped persons and supplementing Title 30 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. The purpose of this act is to further the policy of the State
- 2 to encourage and assist blind and other severely handicapped
- 3 persons to achieve maximum personal independence through pro-
- 4 ductive employment by assuring a continuous market for their
- 5 commodities and services, thereby enhancing their dignity and
- 6 capacity for self-support and minimizing their dependence on
- 7 welfare and the need for costly institutionalization.
- 1 2. As used in this act;
- a. "Blind person" means a person whose vision in his better
- 3 eye with proper correction does not exceed 20/200 or who has a
- 4 field defect in his better eye with proper correction which contracts
- 5 the peripheral field so that the diameter of the visual field subtends
- 6 an angle no greater than 20 degrees.
- 7 b. "Central nonprofit agency" means an agency designated by
- 8 the commissioner pursuant to section 6 of this act.
- 9 c. "Commissioner" means the Commissioner of the Department
- 10 of Human Services.
- 11 d. "Rehabilitation facility" means a rehabilitation facility

STATEMENT

This bill would establish in the Department of Human Services a Commodities and Services Council for the purpose of assuring a State agency market for the commodities and services produced by blind and other severely handicapped persons in approved rehabilitation facilities, thereby enhancing training and work opportunities for said persons and ultimately encouraging and assisting them to achieve maximum independence and personal dignity through productive employment.

The list of commodities and services which are set aside for purchase through the approved rehabilitation facilities will be jointly developed by the council and the Division of Purchase and Property.

DATED: JUNE 29, 1981

This bill requires State agencies to purchase certain services and commodities produced by blind and other severely handicapped individuals working in rehabilitation facilities, such as sheltered workshops, and establishes a Commodities and Services Council in the Department of Human Services.

The members of the council shall include representatives from State agencies (i.e., the Divisions of Vocational Rehabilitation Services and Purchase and Property, the Commission for the Blind and Visually Impaired, and the Bureau of State Use Industries), organized labor, business, and the public. The council is required to develop a list of commodities and services produced by the facilities that will be set aside for purchase by State agencies and to establish a fair market price for the items. The council will recommend to the commissioner a central nonprofit agency which will be responsible for coordinating the production and purchase of the items.

The Department of Human Services strongly supports this legislation.

The committee agreed with the concept of this legislation and released the bill without amendment.

As amended, this bill requires State agencies to purchase certain commodities and services produced by blind and other severely handicapped persons in rehabilitation facilities and establishes a Commodities and Services Council in the Department of Human Services.

The members of the council include representatives from State agencies, business, organized labor and the public. The council is required to develop a list of commodities and services produced by rehabilitation facilities that will be set aside for purchase by State agencies and to establish a fair market price for the items. The council also will recommend to the commissioner a central nonprofit agency which will be responsible for coordinating production and purchasing of the commodities.

Committee amendments delete subsection e. of section 7 to clarify the duties of the central nonprofit agency.

LEGISLATIVE FISCAL ESTIMATE TO

SENATE, No. 1673

DATED: JUNE 8, 1981

Senate Bill No. 1673 of 1980 establishes a commodities and services council for the blind and other severely handicapped persons.

"This legislative fiscal estimate has been produced by the Office of Legislative Services due to the failure of the Executive Branch to respond to our request for a fiscal note."

The Office of Legislative Services states that enactment of this legislation would result in a minimal expenditure to the State.

In compliance with written request received, there is hereby submitted a fiscal estimate for the above bill, pursuant to P. L. 1980, c. 67.

JANUARY 13, 1982

S-1673, sponsored by Senator John Caufield (D=Essex), establishing a Commodities and Services Coucil within the Department of Human Services to assure a state agency market for products produced by the blind and the handicapped.

<u>S-3504</u>, sponsored by Senator John Russo (D-Ocean), providing that a deputy clerk of the Appellate Division of the State judiciary be in the unclassified division of the civil service.

<u>S-3157</u>, sponsored by Senator Steven Perskie (D-Atlantic), providing for a uniform method of fixing municipal ward boundaries, as recommended by the County and Municipal Government Study (Musto) Commission.

The bill applies to all municipalities (52 in the State) which have wards, and boundaries would be fixed following adoption of certain government forms; following adoption of an ordinance requiring ward divisions; and following the promulgation by the Governor of the decennial federal census.

Ward boundaries will be darrowly drawn--with no more than a 10-percent population deviation between wards--by a commission consisting of members of the county board of elections. No changes in the boundaries can be made within 75 days of a primary or general election.

S-3351, sponsored by Senator Wayne Dumont Jr. (R-Sussex), appropriating \$600,000 for the initial costs of establishing county colleges in Sussex and Warren Counties. Under the bill, the new colleges, needed because of the increased student populations in these counties, will operate out of existing school buildings. The money will not be used for the construction of any new buildings or campuses.

<u>S-1549</u>, sponsored by Senator Joseph Merlino (D-Mercer) and known as the "Community Development Bond Act of 1982," would authorize the issuance of \$85 million in bonds for urban revitalization: \$45 million for a State program similar to the federal UDAG program, to be administered by the flew Department of Commerce; \$30 million for capital construction projects in cities, to be administered by the Department of Community Affairs; and \$10 million for industrial parks, to be administered by the Economic
