- 1 Be it enacted by the Senate and General Assembly of the State

- 1 1. *[Any law, rule or regulation to the contrary notwithstand-
- 2 ing, **A municipality may provide by resolution that* where a
- 3 tenant residing in a structure of two dwelling units or more, is
- 4 displaced from his dwelling by fire or other emergency, and the
- 4A damage resulting from the fire or other emergency in the judgment

DATED: FEBRUARY 23, 1981

Senate Bill 3055 would authorize the disbursement of relocation assistance funds to tenants displaced from their dwellings as a result of fire or other emergency. The bill applies only to tenants residing in structures of two or more dwelling units. The housing inspector would be required to make a determination that the dwelling has been rendered uninhabitable.

Currently, the "Relocation Assistance Act" is available only to persons displaced by State or local land acquisition programs, building code enforcement, or voluntary rehabilitation programs under governmental supervision.

SENATE BILL NO. 3055

To the Senate:

Pursuant to Article V, Section I, Paragraph 14(b) of the Constitution,

I herewith return Senate Bill No. 3055 with my objections for reconsideration.

This bill would require municipalities to provide relocation assistance to tenants who are displaced by fire or other emergency which renders their dwellings uninhabitable. In these times of fiscal constraints I am concerned that this bill will place a heavy burden upon many municipalities. Accordingly, I recommend that the bill be amended to permit municipalities to offer such relocation assistance without mandating that they do so. I also suggest that the bill be clarified to assure that State relocation assistance continue to be used in situations where the assistance is mandatory, not optional.

Therefore, I am returning Senate Bill No. 3055 for reconsideration and recommend that it be amended as follows:

Page 1, Section 1, line 1: Delete in its entirety and insert
"A municipality may provide by
resolution that"

Page 1, Section 1, line 10: Add "State appropriations of relocation assistance shall not be used for this purpose unless specifically permitted by language in the appropriations act."
