# STATE OF NEW JERSEY

#### DATED: JANUARY 17, 2013

The Assembly Transportation, Public Works and Independent Authorities Committee reports favorably and with committee amendments Assembly Bill No. 3253.

As amended and reported, this bill exempts emergency service vehicles, and vehicles used for a safety service patrol or emergency service patrol program operated by the Department of Transportation (DOT), from the law limiting vehicles to one spot lamp. The bill also provides that a spot lamp not be used in a way that is distracting or glaring. Under the bill, emergency service vehicles include, but are not limited to, law enforcement vehicles, ambulances, and official fire department vehicles.

#### **COMMITTEE AMENDMENTS:**

The committee amended the bill to exempt emergency service vehicles including, but not limited to, law enforcement vehicles, ambulances, and official fire department vehicles, and vehicles used for a safety service patrol or emergency service patrol program operated by the DOT from the law limiting motor vehicles to no more than one spot lamp. The committee also clarified that the use of a spot lamp is not to be distracting to any person.

with Assembly Floor Amendments (Proposed by Assemblyman COUGHLIN)

#### ADOPTED: MARCH 21, 2013

These Assembly floor amendments specify that authorized emergency vehicles, incident management response team vehicles, and safety service patrol vehicles are exempted from the law limiting the number of spot lamps a vehicle is permitted to have.

Authorized emergency vehicles are defined in R.S.39:1-1 to mean vehicles of the fire department, police vehicles, and such ambulances and other vehicles as are approved by the Chief Administrator of the New Jersey Motor Vehicle Commission when operated in response to an emergency call.

The amendments define "incident management response team vehicle" to mean a vehicle operated by the Department of Transportation (department) or by a private entity under contract with the department which is equipped to respond at any time to assist the State Police with highway incidents and "safety service patrol vehicle" to mean a vehicle operated by the department or by a private entity under contract with the department which is equipped to respond to highway incidents and provide assistance to motorists in disabled vehicles during designated hours in designated coverage areas in the State.

The Senate Transportation Committee reports favorably and with committee amendments Senate Bill No. 2335.

As amended and reported, this bill exempts emergency service vehicles, and vehicles used for a safety service patrol or emergency service patrol program operated by the Department of Transportation (DOT), from the law limiting vehicles to one spot lamp. The bill also provides that a spot lamp not be used in such a way as to be distracting or glaring. Under the bill, emergency service vehicles include, but are not limited to, law enforcement vehicles, ambulances, and official fire department vehicles.

with Senate Floor Amendments (Proposed by Senator VITALE)

ADOPTED: MAY 13, 2013
