The notation is to be used solely by law enforcement officials or emergency medical professionals to diagnose a person who has been rendered unable to communicate due to a diabetic seizure.

The notation will conspicuously display the statement "INSULIN DEPENDENT DIABETIC" and be displayed in a manner determined by the chief administrator.

This bill was pre-filed for introduction in the 2012-2013 session pending technical review. As reported, the bill includes the changes required by technical review, which has been performed.

- The Motor Vehicle Commission (MVC) will be required to have two items of programming and two change orders with its vendors in order to implement this legislation.
- It is not known what the cost of the programming or the change order components will be. The Office of Legislative Services (OLS) concludes that programming/design elements can largely be completed with the assistance of Office of Information Technology (OIT), and the change orders are expected to be comparable to other change orders that the MVC has issued to its vendors in the past, not significantly altering the existing contract with the license vendor or the vendor implementing the MATRX program.

#### **BILL DESCRIPTION**

Assembly Bill No. 945 of 2012 would require the Chief Administrator of the MVC, at the voluntary request of a licensee, to allow a driver's license to include a notation that the licensee suffers from diabetes, is insulin dependent and, as a result, may be susceptible to convulsive seizures. The OLS concludes that it is not possible to estimate with precision the cost of Assembly Bill No. 945. The bill would require a minor redesign of the existing driver's license in order to identify a location on the license for the display of a driver's diabetic status. The MVC has existing staff capable of such design work on the license. Once a location for such a designation is decided it will be necessary to work with the current driver's license vendor to redesign the software that produces driver's licenses to incorporate those changes. The MVC periodically makes change orders of this type, but the OLS does not have access to the cost or nature of these change orders, so it is not possible to derive an estimate from a comparable change order.

The MVC also must accommodate such a change in its ongoing upgrades to its technology system, known as MATRX. These upgrades include actions such as updating the computer language used on legacy MVC databases, allowing the MVC to conduct basic transactions online, and developing a computer framework that would allow for mobile or temporary MVC locations. Based on consultation with the MVC staff, it appears that any MATRX related programming can be conducted by OIT, but would likely require an eventual change order to be filed with the MATRX vendor. The MVC has indicated that such a change order would be similar in scope to other orders that the MVC has made, and that such an order would not be billed separately, but is likely to be batched with those other orders as part of a negotiated cost package. This will make it difficult to identify the cost of the change orders, even after the work has been performed.

The cost of the changes proposed by this legislation is unlikely to have a significant impact on the annual MVC or OIT budget.

The MVC periodically makes change orders of this type, but the OLS does not have access to the cost or nature of these change orders, so it is not possible to derive an estimate from a comparable change order.

The MVC also must accommodate such a change in its ongoing upgrades to its technology system, known as MATRX. These upgrades include actions such as updating the computer language used on legacy MVC databases, allowing the MVC to conduct basic transactions online, and developing a computer framework that would allow for mobile or temporary MVC locations. Based on consultation with the MVC staff, it appears that any MATRX related programming can be conducted by OIT but would likely require an eventual change order be filed with the MATRX vendor. The cost of the changes proposed by this legislation are unlikely to have a significant impact on the annual MVC or OIT budget and will likely not require an additional appropriation or subsidy from the Legislature. If a budgetary cost is realized, it would likely be in the form of a slightly increased appropriation to Motor Vehicle Services in the next budget year, to maintain the surplus that the MVC carries from year to year in order to ensure its financial health as a quasi-independent government operation.

The cost of the changes proposed by this legislation are unlikely to have a significant impact on the annual MVC or OIT budget and will likely not require an additional appropriation or subsidy from the Legislature. If a budgetary cost is realized, it would likely be in the form of a slightly increased appropriation to Motor Vehicle Services in the next budget year, to maintain the surplus that the MVC carries from year to year in order to ensure its financial health as a quasi-independent government operation.
