AN ACT to amend the "emergency transportation tax act," approved May 29, 1961 (P. L. 1961, c. 32).

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 57 of P. L. 1961, c. 32 (C. 54:8A-57) is amended to read 2 as follows:

3 57. This act shall take effect immediately, but the tax imposed hereby, and the obligation to pay the same as well as the obligation 4 to deduct and withhold shall be suspended and inoperative in the $\mathbf{5}$ 6 event that any of the moneys in the Transportation Fund shall be 7 applied to a purpose or purposes other than one set forth in this 8 act, from the date when such application is made until the amounts to be refunded to taxpayers as a result thereof have been allowed 9 and paid; and the tax hereby imposed shall cease to be imposed, 10 assessed and collected after the assessment thereof for any taxable 11 year ending December 31, [1980] 1990, and for any part of a tax-12able year beginning during the year [1980] 1990 and ending Decem-1314 ber 31, [1980] 1990.

1 2. This act shall take effect immediately.

STATEMENT

Governor Brendan Byrne today signed the following bills:

<u>A-465</u>, sponsored by Assemblyman Walter Kern Jr. (R-Bergen), which allows counties to establish and staff county civil rights offices. Such an office, if granted authority by the Attorney General, will be permitted to investigate, conciliate, and make recommendations. However, all actual and final decision-making powers will be reserved for and maintained by the State civil rights office.

Previously, only municipalities in a county with a population of 200,000 were permitted to establish civil rights offices. This bill prohibits any county in which a municipality has already established a civil rights office from establishing a county civil rights office.

<u>A-682</u>, sponsored by Assemblyman James W. Bornheimer, (D-Middlesex), which amends the Life and Health Insurance Code to allow a New Jersey based insurer and its subsidiaries to invest in more than 8 percent but less than a majority of the voting stock of a corporation outside of New Jersey.

Corporations outside of New Jersey in which investments would now be allowed are those that are engaged in any type of insurance business or engaged in the type of services the domestic insurer might itself perform.

<u>A-1534</u>, sponsored by Assemblyman Richard Van Wagner, (D-Monmouth), which extends the Emergency Transportation Tax Act the income tax imposed on New York residents who work in New Jersey. The act currently expires on December 31, 1980. This bill extends the expiration date to December 31, 1990.

<u>S-881</u>, sponsored by Senator Wynona Lipman (D-Newark), which provides that certain county investigators with customary duties involving personal risks will be allowed to transfer their memberships in the Public Employees' Retirement System to the Police and Firemen's Retirement System.
