STATEMENT

The purpose of this bill is to authorize county park commissions in counties of the second class to expend as much as \$50,000.00, annually, in the maintenance and operation of county parks, when such money becomes available as a result of the acquisition of

any county park commission parkland by the State for highway purposes.

In the case of highly developed counties, or counties with an already extensive municipal, county and State park system, the problems of county park maintenance, and the rising costs of county park operations, often become more important priorities than parkland acquisition. In light of those conditions, it may well be appropriate to authorize limited expenditures on maintenance and operations when funds are provided by the State, in payment for park commission property taken for State Highway purposes. This bill would provide the necessary statutory authority to make such expenditures.

The purpose of this bill is to permit, upon the approval of the governing body, county park commissions in counties of the second class to expend up to \$50,000.00 annually for park maintenance and operation under certain circumstances.

Under the provisions of the bill, whenever certain second class counties transfer or convey parklands or parkways to the State for State highway purposes, the governing body may release up to \$50,000.00 of the moneys received for such transfer or conveyance to the county park commission for maintenance and operation purposes.

The bill further provides that the balance of any such moneys shall be applied to retire any outstanding county bonds issued for the purpose of acquiring or improving those parklands or parkways which have been transferred to the State. Any remaining moneys are to be set aside by the park commission for capital improvement purposes and, if approved by the governing body of the county, the acquisition of additional park lands.

Governor Brendan Byrne today signed <u>S-1431</u>, sponsored by Senator Frank X. Graves (D-Passaic), which permits county park commissioners to spend as much as \$50,000 annually in maintenance and operation of parks when such money becomes available as a result of the acquisition of parkland by the State for highway purposes.
