An Act concerning civil service, and amending sections 11:12-1 and 11:22-6 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State

- 1 1. R. S. 11:12-1 is amended to read as follows:
- 2 11:12-1. Appointments and promotions to positions in the com-
- 3 petitive, noncompetitive and labor classes of the classified service,
- 4 with the exception of appointments to entry level law enforce-
- 5 ment and entry level firefighter titles, shall be for a probationary

Senate Bill No. 1054 would amend R. S. 11:12-1 and R. S. 11:22-6 which provide for probationary periods for appointments of law enforcement officers and firefighters.

The provisions of this legislation were previously discussed with Civil Service Commissioner Howard S. Woodson, at the committee's February 9, 1978 meeting, when the committee reviewed with the commissioner new regulations of the department relating to appointment standards for firefighters. At that time both the commissioner and the committee agreed that the current probationary period is too short to allow the appointing authority sufficient opportunity to properly evaluate the ability of a new appointee to perform his duties and to assimilate job related information. The committee indicated that legislation extending the probationary period would be given priority consideration upon receipt.

This bill would accomplish this purpose by extending the probationary period for entry level appointments of law enforcement officers from a maximum of 6 months to 12 months, and of firefighters from 3 months to 12 months. The bill would provide for written progress reports from the appointing authority for such appointments at 6 months and at 9 months.

They are also required to establish boards of directors which could not have more than 40 per cent of the members affiliated with extenders of credit.

The bill will take effect immediately, but will remain inoperative for 90 days.

Violators of the act would be subject to a \$500 fine.

S-1054, sponsored by Senator John Gregorio (D-Union), which extends the probationary period of civil service for police and firemen.

Under the bill, the probationary period for state police and firemen in the classified civil service is increased from four months to 12 months and the probationary period for entry level county and municipal police and firemen is increased from three months to 12 months.

The bill also provides for written progress reports from the appointing authority for such appointments at six and nine months.

The purpose of the bill is to allow the appointing authority sufficient time to properly evaluate the ability of a new appointee to perform his duties and assimilate job-related information.

<u>S-1371</u>, sponsored by Senator Matthew Feldman (D-Bergen), which extends the reporting date of the Commission on Individual Liberties and Personal Privacy from January 15, 1979, to June 30, 1979, and appropriates \$10,000 for the work of the Commission.
