Governor Brendan Byrne signed the following bills into law yesterday before leaving for Europe on the trade mission:

S-1102, sponsored by Senator John Skevin (D-Bergen) which makes it lawful for a person to engage in the conducting of bingo games for more than one affiliated licensee of which he is an active member.

Under the original "Bingo Licensing Law", only active members of a bingo licensee could participate in running the licensee's bingo games and a person could not work for more than one licensee during the same calendar year.

SJR-23, sponsored by Senator Lawrence S. Weiss (D-Middlesex) which designates 1979 as "The Thomas Alva Edison Centennial Year" in New Jersey and directs the New Jersey Historical Commission to work with other public and private agencies in planning and holding a statewide observance of the 100th anniversary of Thomas Edison's career as an inventor.

Edison invented the incandescent light bulb, probably his most famous invention, in 1879.

The commemorative observance will include educational, cultural and scholarly activities to increase awareness and appreciation of Edison's inventions (including the phonograph, the light bulb and the motion picture camera) and of his profound influence on modern science and technology.

A-1771, sponsored by Assemblyman Walter Rand (D-Camden) which amends the New Jersey Gross Income Tax Act to exclude from the tax lump sum transfers from a qualified retirement plan when the taxpayer places the entire sum into an individual retirement account in accordance with the provisions of the Federal Internal Revenue Code.

The purpose of the bill is to conform state treatment of pension income to the federal law.
