INTRODUCED OCTOBER 19, 1978

By Senators FELDMAN, SCARDINO, HERBERT, SKEVIN, YATES and LIPMAN

Referred to Committee on Education

An Acr authorizing the Board of Higher Education to contract with eligible independent colleges and universities for educational services to the State and repealing "The Independent Colleges and Universities Utilization Act," P. L. 1972, c. 67.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. This act shall be known and may be cited as the "Independent
- 2 College and University Assistance Act."
- 1 2. The Legislature finds and determines that:
- 2 a. This State remains committed by law and public policy to the
- 3 development and preservation of a planned and diverse system of
- 4 higher education which encompasses both public and independent
- 5 institutions. Independent institutions make an important contribu-
- 6 tion to higher education in the State and it is in the public interest
- 7 to assist these institutions in the provision and maintenance of
- 8 quality academic programs.
- 9 b. The provisions of this act will serve the cause of higher educa-
- 10 tion in this State by assuring maximum educational choice among
- 11 colleges and universities through the preservation of the vitality
- 12 and quality of independent institutions of higher education in this
- 13 State.
- 1 3. As used in this act:
- a. "Eligible institution" or "institution" means only those in-
- 3 dependent institutions of higher education incorporated and located
- 4 in this State, which, by virtue of law or character or license, are
- 5 non-profit educational institutions empowered to grant academic
- 6 degrees and which provide a level of education which is equivalent

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law.

STATEMENT

The current method for allocating State aid to independent colleges and universities is based on the increased number of New Jersey students at each institution. Present legislation authorizes the payment of \$600.00 for each additional full-time New Jersey undergraduate student enrolled from the year before plus \$175.00 for each freshman and sophomore and \$225.00 for each junior and senior full-time New Jersey undergraduate student enrolled the previous year.

This bill ties the level of State aid to independent colleges and universities to 25% of the per student support level to the State colleges.

These funds would be distributed in the following manner:

- 1. Ten percent divided equally among all eligible institutions;
- 2. Thirty-five percent according to the number of New Jersey students receiving State financial aid or \$1,000.00 or more of aid administered by the institution;
- 3. Fifty-five percent according to the number of full-time equivalent students.

The new funding formula better reflects the fact that college enrollments are no longer growing but rather have stabilized. Funding based on the number of full-time equivalent rather than full-time only students acknowledges the increasing number of part-time students. Tying the level of aid to the independent colleges and universities to the level of support for the State colleges recognizes the fact that the same inflationary forces affect the public and private colleges and universities. \$1402 (1979)

Provisions:

1.11

The Senate Education Committee favorably reports this bill which revises the method for allocating State support for the independent colleges. The appropriation for this program will be calculated by multiplying the number of full-time equivalent (FTE) New Jersey undergraduates in the independent colleges by 25% of the average "direct per student support" for the State colleges (see "Background," below).

The aid would be distributed as follows:

(1) 10% divided equally among the institutions.

(Note: Any institution which does not enroll a sufficient number of New Jersey students would lose part or all of this minimum aid.)

- (2) 35% distributed according to the number of New Jersey students receiving State or institutional financial aid of \$1,000.00 or more.
- (3) 55% distributed according to the number of New Jersey students enrolled.

The attached chart illustrates the differences between Senate Bill No 1402 and the current program of aid to independent colleges.

PROBLEM ADDRESSED:

The current statute provides aid for specific categories of students in a fixed dollar amount (see chart) and the major incentive is for expanding the enrollment of New Jersey students. This presents two major problems to the independent colleges.

First, the period of expansion in higher education has ended and we have entered a period of stability. This would indicate that some

change in the weighting of various categories of students is necessary if support is to be maintained.

Secondly, the fixed dollar amounts have not been adjusted for inflation. While there has been some increase in the actual dollar appropriation:—

FY 1973 \$7,000,000 FY 1979 \$8,303,000

this in no way reflects the increase in educational costs over this 6-year period.

An additional problem is that the current law only provides funding for full-time students. In all public sectors, funding is based on fulltime equivalent students. This provides support for part-time students, who represent an increasingly large proportion of higher education enrollments.

COMMITTEE AMENDMENTS:

The Senate Education Committee amendments are designed to clarify the definition of "direct net per student support," which is one of the major components in the new aid to independents formula.

Senate Bill No. 1402 OCR repeals "the Independent Colleges and Universities Utilization Act" (P. L. 1972, c. 67) and establishes in its place a new aid program for those schools, the "Independent College and University Assistance Act."

The funding level for the "Independent College and University Assistance Act," subject to the availability of appropriations, is determined by multiplying 25 percent of the average per pupil net State support for the State colleges by the number of New Jersey full-time equivalent students that are enrolled in the independent institutions. This total amount of money is then distributed to the eligible institutions based on the total number of New Jersey full-time equivalent students enrolled, the number of New Jersey full-time equivalent students receiving financial aid of \$1,000.00 or more, and an equal distribution of 10 percent of the total amount available for the program.

The statement prepared by the Senate Education Committee summarizes the major provisions of the bill and compares them with the provisions of the current program.

A fiscal note on the bill is not available. Estimates prepared by the Department of Higher Education, however, indicate that full funding of the new program in fiscal year 1979-80 would cost \$11.8 million, \$2.9 million more than the amount provided in the appropriation act for the current aid to independents program.

Committee Amendments

Amendments adopted by the committee provide greater specificity for the definition of "direct per student support for the State College Sector," and provide for a clearer understanding of the time frame in which program costs are determined. The amendments also add a new section to the bill. It indicates that if the program is not fully funded, a pro rata distribution is to be made. The effective date is also changed from July 1, 1979 to July 1 of the year following enactment. Lastly, the committee changed from 30 to 32 the number of credit hours used to define a full-time equivalent student. This was done to be consistent with the procedure used for the State colleges.
