

Assembly Bill No. 1311 amends R. S. 40:23-6 to permit counties to contribute funds to the County Officers Association of New Jersey for membership dues and services rendered. Counties are now authorized to so contribute to the New Jersey Association of Counties. The committee understands that the County Officers Association is a separate association, whose membership consist of certain statutory and constitutional officers of counties, including county clerks and recording officers. A-3326, sponsored by Assemblyman Richard Van Wagner (D-Monmouth) which amends the Savings Institution Tax Act to eliminate income from federal and state obligations from an institution's tax base.

The bill also lowers the rate of taxation on the obligations from 5 per cent to 3 per cent.

<u>A-1311</u>, sponsored by Assemblyman Raymond Lesniak (D-Union), which permits counties specifically to contribute funds to the County Officers Association of New Jersey for membership dues and services. Counties are now statutorily authorized to contribute to the New Jersey Association of Counties.

Under prior law, the counties could pay the Association of Counties directly. However, because there was no specific authorization for counties to contribute to the County Officers Association, the members were paid on a reimbursable basis.
