

The purpose of this bill is to permit sessions of the New Jersey Legislature to be held at places other than Trenton on a temporary basis.

The committee amended the bill to restrict such sessions to only ceremonial or commemorative occasions; the provision for such sessions to be held for emergency purposes was deleted.
