An Act concerning the practice of veterinary medicine with respect to ** [abandoned] ** **unretrieved ** animals and supplementing chapter 16 of Title 45 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. This act shall be known and may be cited as the "New Jersey
- 2 ** Abandoned ** ** Unretrieved ** Animal Act."
- 1 2. As used in this act:
- 2 "** [Abandoned] ** *** Unretrieved ** animal" means an animal
- 3 placed for confined treatment or boarding by its owner or an agent
- 4 thereof in the care and custody of a veterinarian or boarding
- 5 kennel, which animal is not retrieved by the owner or agent thereof
- 6 from the veterinarian within 72 hours of being notified **in any
- 7 manner** that the confined treatment is completed or from the

- 9 be boarded**[, and to which its owner or his agent relinquishes 9A all rights]**.
