# SENATE, No. 3183 STATE OF NEW JERSEY

INTRODUCED APRIL 26, 1979

By Senator MUSTO

Referred to Committee on State Government, Federal and Interstate Relations and Veterans Affairs

AN ACT to amend "An act for the establishment of a police and firemen's retirement system for police, firemen and certain other law enforcement officers," approved May 23, 1944 (P. L. 1944, c. 255) as said title was amended by P. L. 1976, c. 139.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. Section 1 of P. L. 1944, c. 255 (C. 43:16A-1) is amended to 2 read as follows:

3 1. As used in this act:

(1) "Retirement system" shall mean the Police and Firemen's 4 5 Retirement System of New Jersey as defined in section 2 of this act. (2) "Policeman or fireman" shall mean any permanent and full-6 time active uniformed employee, and any active permanent and 7full-time employee who is a detective, lineman, fire alarm operator 8 or inspector of combustibles of any police or fire department. It 9 shall also mean any permanent, active, and full-time officer em-10 ployee of the State of New Jersey, or any political subdivision 11 thereof, with police powers and holding one of the following titles: 12 motor vehicles officer, motor vehicles sergeant, motor vehicles lieu-13tenant, motor vehicles captain, assistant chief, bureau of enforce-14 ment, and chief, bureau of enforcement in the Division of Motor 15 Vehicles, [inspectors, and investigators, in the Division of Alcoholic 16 Beverage Control, alcoholic beverage control investigators, alco-17 holic beverage control inspectors, assistant deputy director, bureau 18 19 of enforcement, and deputy director, bureau of enforcement in the 20Division of Alcoholic Beverage Control, conservation officer, assist-21ant district conservation officer, district conservation officer, and 22chief conservation officer, in the Division of Fish, Game, and Shell 23Fisheries, rangers, and chief ranger in the Bureau of Parks, marine 24patrolman, senior marine patrolman, principal marine patrolman, N-Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted in the law. 49 (3) "Member" shall mean any policeman or fireman included
50 in the membership of the retirement system as provided in section
51 3 of this act.

52 (4) "Board of trustees" or "board" shall mean the board pro-53 vided for in section 13 of this act.

54 (5) "Medical board" shall mean the board of physicians pro-55 vided for in section 13 of this act.

(6) "Employer" shall mean the State of New Jersey, the county,
municipality or political subdivision thereof which pays the particular policeman or fireman.

59 (7) "Service" shall mean service as a policeman or fireman paid60 for by an employer.

61 (8) "Creditable service" shall mean service rendered for which62 credit is allowed as provided under section 4 of this act.

63 (9) "Regular interest" shall mean interest as determined
64 annually by the State Treasurer after consultation with the
65 Directors of the Divisions of Investment and Pensions and the
66 actuary of the system. It shall bear a reasonable relationship to

67 the percentage rate of earnings on investments but shall not exceed68 105% of such percentage rate.

(10) "Aggregate contributions" shall mean the sum of all the
amounts, deducted from the compensation of a member or contributed by him or on his behalf, standing to the credit of his individual account in the annuity savings fund.

(11) "Annuity" shall mean payments for life derived from theaggregate contributions of a member.

(12) "Pension" shall mean payments for life derived fromcontributions by the employer.

(13) "Retirement allowance" shall mean the pension plus theannuity.

(14) "Earnable compensation" shall mean the full rate of the salary that would be payable to an employee if he worked the full normal working time for his position. In cases where salary includes maintenance, the retirement system shall fix the value of that part of the salary not paid in money which shall be considered under this act.

85 (15) "Average final compensation" shall mean the average annual salary upon which contributions are made for the 3 years 8687 of creditable service immediately preceding his retirement or death, or it shall mean the average annual salary for which contributions 88 are made during any 3 fiscal years of his or her membership pro-89 viding the largest possible benefit to the member or his beneficiary. 9091 (16) "Retirement" shall mean the termination of the member's active service with a retirement allowance granted and paid under 92the provisions of this act. 93

94 (17) "Annuity reserve" shall mean the present value of all pay-95 ments to be made on account of any annuity or benefit in lieu of 96 any annuity computed upon the basis of such mortality tables 97 recommended by the actuary as shall be adopted by the board of 98 trustees, and regular interest.

99 (18) "Pension reserve" shall mean the present value of all pay-100 ments to be made on account of any pension or benefit in lieu of 101 any pension computed upon the basis of such mortality tables 102 recommended by the actuary as shall be adopted by the board of 103 trustees, and regular interest.

(19) "Actuarial equivalent" shall mean a benefit of equal value
105 when computed upon the basis of such mortality tables recom106 mended by the actuary as shall be adopted by the board of trustees,
107 and regular interest.

108 (20) "Beneficiary" shall mean any person receiving a retire-109 ment allowance or other benefit as provided by this act. 110 (21) "Child" shall mean a deceased member's or retirant's 111 unmarried child either (a) under the age of 18 or (b) of any age 112 who, at the time of the member's or retirant's death, is disabled 113 because of mental retardation or physical incapacity, is unable to 114 do any substantial, gainful work because of the impairment and his 115 impairment has lasted or can be expected to last for a continuous 116 period of not less than 12 months, as affirmed by the medical board. 117 (22) "Parent" shall mean the parent of a member who was 118 receiving at least one-half of his support from the member in the 119 12-month period immediately preceding the member's death or the 120 accident which was the direct cause of the member's death. The 121 dependency of such a parent will be considered terminated by 122 marriage of the parent subsequent to the death of the member.

123 (23) "Widower" shall mean the man to whom a member or 124 retirant was married at least [5] 2 years before the date of her 125 death and to whom she continued to be married until the date of her 126 death and who was receiving at least one-half of his support from 127 the member or retirant in the 12-month period immediately preced-128 ing the member's or retirant's death or the accident which was the 129 direct cause of the member's death. The dependency of such a 130 widower will be considered terminated by marriage of the widower 131 subsequent to the death of the member or retirant. In the event of 132 the payment of an accidental death benefit, the [5] 2-year qualifica-133 tion shall be waived.

134 (24) "Widow" shall mean the woman to whom a member or 135 retirant was married at least [5] 2 years before the date of his 136 death and to whom he continued to be married until the date of 137 his death and who has not remarried. In the event of the payment 138 of an accidental death benefit, the [5] 2-year qualification shall be 139 waived.

(25) "Fiscal year" shall mean any year commencing with July 1,141 and ending with June 30, next following.

142 (26) "Compensation" shall mean the base salary, for services 143 as a member as defined in this act, which is in accordance with 144 established salary policies of the member's employer for all em-145 ployees in the same position but shall not include individual salary 146 adjustments which are granted primarily in anticipation of the 147 member's retirement or additional remuneration for performing 148 temporary duties beyond the regular work day.

(27) "Department" shall mean any police or fire department of a municipality or a fire department of a fire district located in a township or a county police or park police department or the appropriate department of the State or instrumentality thereof.

1 2. This act shall take effect immediately.

## STATE OF NEW JERSEY

### DATED: MAY 24, 1979

The purpose of this bill is to reduce the number of years of marriage required by the Police and Firemen's Retirement System for a spouse to be considered a widow or widower and thus eligible to receive survivor's benefits upon the death of a member or retirant. Under the present law the requirement is 5 years of marriage. The bill would make 2 years of marriage the required period.

The Division of Pensions estimates that there are approximately 5,000 widows and widowers who are currently receiving survivor's benefits. The division further estimates that an additional 10% of this number would become eligible pursuant to this amendment. Survivor's benefits amount to about 25% of annual salary. The salary for members of this retirement system averages between \$16,000.00 and \$18,000.00 per year, thus the present widows made eligible for survivor's benefits by the enactment of this bill would receive between \$4,000.00 and \$4,500.00 per year.

### FISCAL NOTE TO SENATE, No. 3183

Senate Bill No. 3183 lowers from 5 to 2 years the number of years which a member or retirant must be married in order for his or her spouse to be deemed a widow or widower under the provisions of the Police and Firemen's Retirement System and be eligible for survivor's benefits.

The Division of Pension comments:

"Aside from the possibility that communities who do not now participate may suddenly find themselves with substantial cost implications as a result of this legislation, the major cost implication involves the liberalization in the years required for the payment of widow and widower benefits. The cost of a particular widow's benefit can be \$50,000.00 or it can be as much as \$100,000.00 depending on the age of the widow at the time of death. The average pensioner retired on a salary of \$16,000.00-\$18,000.00 so that we are talking about an annual widow's benefit of 25% of salary or at least \$4,000.00 a year for the rest of the woman's life. This is likely to involve a present value of at least \$50,000.00. However, it could be several times that if the member were to marry someone who is substantially younger. Thus the cost does not only involve the limited number of widows who would first become eligible for benefits as a result of this legislation in that they lacked 5 years of marriage but had at least 2 years before the death of the member. The real cost in this legislation involves the incentives for older men to marry younger women and primarily members of their families for the purpose of endowing them with a \$4,000.00 annual annuity. We estimate that this could increase the number of widows by as much as 10% or about 500 widows with a present value cost of \$25 million over the life of the present membership. Again, this may not be the intent of the authors but this could be the result."

Based on the additional \$25 million liability to the system, the Office of Legislative Services estimates the *annual* employer costs of Senate Bill No. 3183 as follows:

> FY 1979-80—no cost (due to lag in actuarial certification) FY 1980-81—\$691,000.00 FY 1981-82—\$763,000.00

The bill also provides that the Director of the Division of Local Government Services establish rules and regulations for municipalities regarding notification of taxpayers, supervision by the tax collector and requirements concerning the holding, use, accounting, reporting and payment to the municipality of public money received by the designated banks or trust companies.

<u>S-3101</u>, sponsored by Senator Wynona M. Lipman (D-Essex), which makes a number of changes in the "Law Against Discrimination" and is designed to reduce the backlog of cases and the costs in the Division of Civil Rights.

It brings New Jersey statutes into compliance with the federal law which currently permits charging parties to request the issuance of a right to sue letter after 180 days have expired and pursue their legal remedies before a court. Also, transcripts of hearings would be prepared only upon the request of a party and the prevailing party may be awarded reasonable attorney's fees.

<u>S-3154</u>, sponsored by Senator Walter E. Foran (R-Hunterdon), which directs the Departmen of Education to provide by September 30, 1982 sufficient in-service training to the child-study teams so they may properly evaluate and program handicapped children with severe hearing losses. Governor Byrne line-item vetoed a \$50,000 appropriation for the bill. A copy of the veto message is attached.

5-3183, sponsored by Senator William V. Musto (D-Hudson), which amends the definition of widow and widower for the purposes of the Police and Firemen's Retirement System.

Under prior law, in order to qualify for widows or widower's benefits, the person must have been married to the member for at least five years prior to the member's death. This bill reduces that requirement to two years.

<u>S-3191</u>, sponsored by Senator William J. Hamilton, Jr. (D-Middlesex), which amends the public bidding laws by providing that when a public contract is to be performed by the State of New Jersey through the Division of Building and Construction for a contract sum of less than \$20,000 the Director of the Division or the Department of State may waive the bond requirement of the act.
