An Act concerning the classification of motor vehicles and the licensing of drivers thereof, amending R. S. 39:3-10, R. S. 39:3-10.1, R. S. 39:3-13 and P. L. 1950, c. 127, and supplementing chapter 3 of Title 39 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State

- 1 1. R. S. 39:3-10 is amended to read as follows:

### SPONSOR'S STATEMENT

This bill embodies several of the recommendations of the Motor Vehicle Study Commission contained in its September, 1975 Report.

It classifies motor vehicles under four classifications as follow:

- a. Motorcycles;
- b. Omnibuses and school buses;
- c. Articulated vehicles (combinations of two or more vehicles joined together);
  - d. Motor vehicles not included in a., b. or c.

Special learner or examination permits and drivers licenses or endorsements are required for each classification, and the licenses or endorsements will be valid for a period of 2 years.

The recommendation covered by this bill will be found on pages 26-27 (permits), 73 (licenses and endorsements), 85 (2-year licenses).

This bill would revise the law regarding the licensing of drivers by requiring vision tests, knowledge of traffic control devices and safe driving practices in addition to the existing requirements. The standards for the vision test would be developed by a medical vision panel created pursuant to Senate Bill No. 1419, a companion measure. The bill establishes four classifications of driver's licenses with learners' or examination permits for each classification. It requires the adoption of one basic license form with endorsements for each of the four classifications which are: (1) basic drivers license; (2) motorcycle license or endorsement; (3) omnibus or school bus endorsement; and (4) articulated vehicle endorsement. Motorcycle licenses may be issued alone. All licenses are valid for a period of two years.

The bill also contains a provision to require drivers of buses transporting pupils to and from private schools to have an omnibus or school bus endorsement. This reflects existing law as per L. 1975, ch. 284 which would take effect January 1, 1977. As amended in committee, the bill would also require all drivers of buses, as defined by the director whether they are for hire or not, to obtain an omnibus or school bus endorsement, provided that they are not specifically excepted under existing law. The intent is to require all drivers of senior citizen buses or drivers of other forms of free bus transportation to obtain the special endorsement on their license. As per the age of majority law, the age for applicants to obtain a school bus or omnibus endorsement is dropped from 21 to 18 years provided they have 3 years of driving experience. Present Division of Motor Vehicles regulations require 3 years. Satisfactory proof of good physical fitness, character and experience must be demonstrated every 24 rather than every 12 months as under present law for all holders of a school bus or omnibus endorsement.

The fees are:

There is also a requirement that the legal name of each driver appear on the license. "Legal name" is defined in the bill and a fine of not more than \$10.00 for failure to notify the director of a name change within 2 weeks is prescribed.

Special learner or examination permits are established under the bill for each classification of license. Licensed driving schools are permitted to teach beginners with dual pedal control vehicles as now allowed through driver education courses in the schools. Persons may obtain a special permit at 16 (presently 16½) years of age if they are enrolled in a driver education course or have contracted with a licensed instructor. At 16½ the special permit holder may retain possession of the permit and drive during daylight hours only while under the supervision of a driver with at least 3 years licensed driving experience.

After the permit is validated for practice driving, the permit holder may be scheduled for a road test.

The committee amended the definition of articulated vehicles so as to conform to the definitions found in R. S. 39:1-1.

As is reflected in the statement accompanying this bill, the various provisions contained herein were based upon the recommendations of the Motor Vehicle Study Commission in their September, 1975, Report.

The intent of this bill is to improve the general license qualifications so as to reflect the varying needs of license applicants.
