

# STATE OF NEW JERSEY

#### INTRODUCED MAY 17, 1976

By Senator ZANE

Referred to Committee on County and Municipal Government

AN ACT concerning the appointment of county court judges in certain counties and supplementing article 2 of chapter 3 of Title 2A of the New Jersey Statutes.

1 BE IT ENACTED by the Senate and General Assembly of the State 2 of New Jersey:

1 1. In counties having a population of more than 125,000 but 2 less than 175,000 according to the 1970 census, there shall be five 3 judges of the County Court in addition to the judge of the county 4 court provided by Article VI, Section V, paragraph 2 of the Con-5 stitution, making six in all in each of said counties, to be nominated 6 and appointed by the Governor with the advice and consent of the 7 Senate.

1 2. This act shall take effect immediately.
