# STATE OF NEW JERSEY

#### INTRODUCED SEPTEMBER 16, 1976

An Act concerning the appointment of county court judges in certain counties and supplementing article 2 of chapter 3 of Title 2A of the New Jersey Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1. In counties of the third class having a population of more
- 2 than 50,000 but less than 65,000 according to the 1970 census, there
- 3 shall be one judge of the county court in addition to the judge of
- 4 the county court provided by Article VI, Section V, paragraph 2
- 5 of the Constitution, making two in all in each of said counties, to be
- 6 nominated and appointed by the Governor with the advice and
- 7 consent of the Senate.
- 1 2. This act shall take effect immediately.

### STATEMENT

The purpose of this bill is to provide for the appointment of one additional county court judge in counties of the third class having a population of 50,000 but less than 65,000 according to the 1970 census.
