An Acr concerning bee diseases and the regulation of apiaries, amending sections 4:6-5, 4:6-12, 4-6-13, 4:6-14, 4:6-15, 4:6-16, 4:6-17 of the Revised Statutes and supplementing chapter 6 of Title 4 of the Revised Statutes.

- 1 Be it enacted by the Senate and General Assembly of the State
- 2 of New Jersey:
- 1 1. R. S. 4:6-5 is amended to read as follows:
- 2 4:6-5. A person in this State engaged in the rearing of queen
- 3 bees for sale shall have his apiary inspected at least twice during
- 4 each summer and a person who shall fail to comply with this require-
- 5 ment shall be liable to a penalty of [\$50.00] \$200.00. The department
- 6 shall inspect all such apiaries at least twice each season, when
- 7 requested by the owner.
- 2. R. S. 4:6-12 is amended to read as follows:

- 5 Any penalty imposed by this act shall be collected or enforced in
- 6 a summary manner, without a jury, in any court of competent

STATEMENT

This bill would update and revise present law relating to the keeping of bees and the control of bee diseases. These changes are needed and supported by the State's bee industry in order to protect the important role of beekeeping in New Jersey's agricultural eoonomy.

DATED: NOVEMBER 8, 1976

This measure updates and supplements the existing law relating to the keeping of bees and the control of bee diseases.

The bill increases the level of fines for, violations of the law. The schedule of fines currently in effect, which were established many years ago, are too low to have effective deterrent value.

The bill also provides a procedure for the proper disposition of abandoned beehives. Such abandoned beehives not only threaten apiaries, but complicate prevention of the numerous thefts of hives.

No opposition to the bill was expressed at the committee meeting.
