## P.L.2015, CHAPTER 33, *approved April 27, 2015* Senate, No. 2626

AN ACT allowing a casino and an out-of-State racetrack to negotiate 1 2 the amount the casino will pay for the transmission of simulcast 3 horse races and amending P.L.1992, c.19. 4 5 **BE IT ENACTED** by the Senate and General Assembly of the State 6 of New Jersey: 7 8 1. Section 11 of P.L.1992, c.19, s.11 (C.5:12-201) is amended 9 to read as follows: 10 11. a. This act shall take effect immediately 28 29 30 **STATEMENT** 31 32 Current law limits the amount that a casino in Atlantic City may 33 pay to an out-of-State racetrack for the transmission of a simulcast 34 horse race to no more than 6% of the pari-mutuel pool on each race 35 or 9% of the pari-mutuel pool on each race in the case of not more than 28 races per calendar year and for races run annually at the 36 37 Breeders' Cup World Cup Championships. This bill would allow a casino and an out-of-State racetrack, instead, to negotiate the 38 39 amount the casino will pay for the transmission of simulcast horse 40 races from the out-of-State sending track. 41 42 43 44 45 Allows casino and out-of-State racetrack to negotiate amount 46 casino will pay for simulcast races.


